SCIENCE

GENERAL SCIENCE

Rabies Virus

- It is a deadly zoonotic disease caused by the Rabies virus (RABV) that attacks the nervous system.
- This virus spreads through the saliva of animals such as dogs and cats.
- It is a vaccine-preventable disease.

Scrub Typhus - Bacteria

- Scrub typhus is caused by bacteria called Rickettsia. When mites, insects, or other organisms infected with Rickettsia bite humans, they can transmit scrub typhus fever.
- The main symptoms include fever, headache, body weakness, and rashes.

European Bats

- Europe's Greater Noctule bats are capable of hunting and eating small migratory birds while flying.
- Previously, it was believed that bats could not perform this behavior.
- Bats have been observed hunting birds at altitudes above 400 meters.
- In one instance, a bat captured a European Complete
 Robin and consumed it continuously while SpaceX's flying for 20 minutes.
- These bats use ultrasonic echolocation, which produces sound frequencies inaudible to birds.
- Additionally, their powerful wingbeats allow them to fly faster than birds, helping them overtake and catch their prey.

Acanthamoeba

- Kerala has reported a rise in amoebic meningoencephalitis cases, a rare but fatal brain infection caused by Acanthamoeba.
- It is a free-living ameba, a kind of one-celled organism that lives in water, soil, and dust.
- It can also be found in swimming pools, hot tubs, drinking water systems, humidifiers, and in heating, ventilation, and air conditioning (HVAC) systems.
- Causes serious infections like Acanthamoeba keratitis (eye) and Granulomatous Amoebic Encephalitis (GAE) (brain).
- It can infect parts of the body through cuts or skin wounds or from being inhaled into
 the lungs or nostrils. It can get into the eyes through contact lens use.

Types of Infections Caused by Acanthamoeba

- Granulomatous amebic encephalitis (GAE), which affects the brain and is almost always fatal
- Cutaneous acanthamoebiasis, a skin infection
- Acanthamoeba rhinosinusitis, an infection of the nasal cavity and sinuses
- Acanthamoeba keratitis: It is an eye infection that typically occurs in healthy people and can cause permanent vision loss.

SPACE

SpaceX's 11th Rocket Test Successfully Completed

- SpaceX's Starship rocket successfully completed its mission during its 11th test flight into space.
- The rocket was launched from SpaceX's Starbase in Texas, orbited the Earth, and deployed mock satellites as in previous tests. It then returned safely to land at the launch site.

 Standing at 123 meters, this is the world's largest and most powerful rocket, and NASA's space exploration program plans to use it in the coming years to send humans to the Moon.

Chandrayaan-2's observations of the lunar exosphere

- India's Chandrayaan-2 lunar orbiter made the first-ever observation of the effects of the sun's Coronal Mass Ejection (CME) on the moon.
- The observation was made by the Chandra's Atmospheric Composition Explorer-2 (CHACE-2) payload onboard the orbiter.
- CHACE-2 showed an increase in the total pressure of the dayside lunar exosphere (the moon's very thin atmosphere) when the CME impacted the moon.

Significance:

- It provides scientific insight into the lunar exosphere and space weather effects on the moon.
- It highlights the challenges for building scientific bases on the Moon, as lunar base architects must account for such extreme events that temporarily alter the lunar environment.

Chandrayaan-2 Mission

- Chandrayaan-2 was launched on July 22, 2019, using the GSLV-MkIII-M1 rocket.
- The mission orbiter carried eight experiment payloads. The Vikram lander lost communication while attempting a soft landing

Gaganyaan mission

- ISRO Chairman V. Narayanan stated that approximately 90% of the development work on the Gaganyaan mission has been completed.
- The mission to launch Indian astronauts into space is planned for 2027.

- Objectives: Demonstrate India's human spaceflight capability by launching crew of 3 members to an orbit of 400 km (Low Earth Orbit) for a 3 days mission and bring them back safely to earth, by landing in Indian sea waters.
- · Components of the Gaganyaan Mission
- The Launch Vehicle Mark-3 (LVM-3): Formerly known as the GSLV Mk-III
- It is a three-stage rocket with:
 - **First stage:** Two solid-fuel boosters strapped to the rocket core.
 - **Second stage**: Powered by two liquidfuelled, clustered Vikas 2 engines.
 - Third stage: Equipped with the CE-20 indigenous cryogenic engine, using liquid hydrogen and liquid oxygen as fuel and oxidiser, respectively.
- Prior to the crewed mission, ISRO plans to undertake three uncrewed missions.
- The first uncrewed mission of Gaganyaan, featuring the female humanoid Vyommitra, is expected to take flight by the end of this year.
 - Two additional uncrewed missions, G-2 and G-3, are also scheduled for launch next year to further validate systems

CMS-03 communication satellite

- The Indian Space Research Organisation (ISRO) will launch military communications satellite CMS-03 on November 2 from the Satish Dhawan Space Centre in Sriharikota.
- It is also known as GSAT-7R, will be launched by the Launch Vehicle Mark 3 (LVM3).
- Weight: Approximately 4,400 kg.

- The heaviest communication satellite to be launched to Geosynchronous Transfer Orbit (GTO) from Indian soil.
- This will be the LVM3 rocket's first launch in over two years, with its last deployment being the launch of the Chandrayaan-3 mission in July 2023.

LVM-3 Rocket

- The LVM-3 rocket with the CMS-03 satellite for coastal surveillance is scheduled to be launched from Sriharikota in Andhra Pradesh on November 2.
- ISRO has so far launched 48 satellites to improve the country's communication facilities.
- In this regard, the service life of the GSAT-7 (Rukmani) satellite, which was launched in 2013, is about to end.
- In its place, ISRO has now designed the stateof-the-art CMS-03 (GSAT-7R) satellite at a cost of about Rs 1,600 crore.
- This satellite is scheduled to be launched from the Satish Dhawan Space Centre in Sriharikota on November 2 by the LVM-3 (GSLV Mark-3) rocket.
- CMS-03 satellite weighs 4,400 kg. It is the heaviest satellite ever launched into orbit.
- This satellite will be used for surveillance missions by the Indian Defense Ministry.
- It will help in monitoring the Indian coastal borders and improving communication services between warships and aircraft.
- This is the 5th launch of the LVM-3 rocket.
- Chandrayaan-3 spacecraft was previously successfully launched by this rocket.
- Latest inventions in science and technology

LATEST INVENTIONS IN SCIENCE AND TECHNOLOGY

NASA's 'Supersonic' Plane

- The US space agency NASA has successfully tested a new 'supersonic' plane that can travel faster than sound.
- The X-59, designed by Lockheed Martin for NASA, was designed with passenger traffic in mind.
- The plane was developed as part of NASA's effort to create a supersonic passenger plane that would not make noise.

New technology discovered that helps aircraft take off and land vertically

- Professor P.A. Ramakrishna, Associate Professor Joel George Manattra, and researcher Ananthupathran of the Department of Aerospace Engineering at IIT Madras have discovered a new technology that helps aircraft take off and land vertically (Vertical Take-off & Landing VTOL).
- Using hybrid rocket propulsion, the aircraft can be launched vertically and land smoothly.
- This does not require long runways. This technology will be of great use in rugged terrains where runways and large airports cannot be built.
- Their research paper has been published in the world-renowned space research journal (Journal of Aeronautical and Space Sciences).

GEOGRAPHY

PHYSICAL GEOGRAPHY

Sawalkote Hydropower Project on Chenab

- An apex committee of the Environment States Ministry has accorded a fresh environmental clearance to the Sawalkote hydroelectric project.
- It is a 1,856 MW run-of-the-river (uses the natural flow of a river with little or no water storage) hydroelectric project located on the Chenab River (a western river under IWT) in Ramban, J&K.
- It is reportedly the first major hydropower project on the Indus rivers to get environmental clearance following India's suspension of the Indus Waters Treaty (IWT) on April 23 (after the Pahalgam terror attack).
- Hydroelectric Project on Chenab River: The project at Kishtwar, the 890-MW Baglihar project at Ramban, and the 690-MW Salal project at Reasi. These projects significantly 0 contribute to the region's energy supply.
- Chenab (or Chandrabhaga River) is the largest tributary of the Indus River, formed by the confluence of the Chandra and Bhaga rivers at Tandi, in Himachal Pradesh.

Almatti dam

 Karnataka is acquiring land to raise the height of Almatti Dam under Upper Krishna Project (UKP) Phase III to expand irrigation and improve water storage.

About Almatti Dam

- A hydroelectric and irrigation project forming the main reservoir of the Upper Krishna Irrigation Project in North Karnataka.
- The dam was completed in July 2005, with an installed power generation capacity of 290 MW.
- Involved: Karnataka. Telangana, Andhra Pradesh, Maharashtra (all riparian states of the Krishna basin).

Northeast Monsoon

- Chenab River hosts the 390-MW Dulhasti 201 The monsoon occurs in the tropical region, roughly between 20° North and 20° South latitudes.
 - India's climate is described as a **monsoon type**.
 - In Asia, this type of climate is mainly found in the south and southeast.

Rainfall in India

- **Southwest Monsoon**: About 75% of India's annual rainfall is received from the southwest monsoon between June and September.
- Northeast Monsoon: This occurs from October to December.

Northeast Monsoon

 Also called the winter monsoon, it is limited in extent and occurs mainly in the southern

peninsular region. It is referred to as the winter rainfall.

Koraput Coffee

- Koraput Coffee is a type of high-quality, sustainable Arabica coffee grown by tribal farmers in the Koraput district of Odisha, India.
- Koraput Coffee has been featured by NITI Aayog under its 'Aakanksha' initiative, which aims to promote rural livelihoods, ecological harmony and the 'Vocal for Local' campaign.

Ethanol blending in petrol

- Union Home Minister Amit Shah stated that sugar mills have greatly benefited from the blending of ethanol with petrol.
- He also mentioned that the country's sugar production has increased by 1 million metric tonnes, while ethanol production capacity has increased fivefold and its distribution tenfold.
- He further announced that the GST on sugar has been reduced from 28% to 5%.

Ethanol

- Ethanol (C□H□OH) is a renewable, easily flammable, and colorless bio-alcohol.
- It is used as a transport fuel.
- In 2025, India achieved its 20% ethanol blending target.

Types of Ethanol

- 1st Generation Ethanol: Produced from food crops such as sugarcane and maize.
- 2nd Generation Ethanol: Produced from crop residues, bagasse, and bamboo.
- 3rd Generation Ethanol: Produced from algae.

India – Third Position – e-waste management

- In 2025, India generated 2.2 million tonnes of e-waste.
- It ranks as the third-largest e-waste generator in the world.
 - Most of this e-waste is informally recycled, causing the release of toxic substances into the

air and water, which leads to health hazards for e-waste workers and the wider community.

E-Waste (Management) Rules, 2022

Focuses on proper recycling.

Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016

 Specifies guidelines for the safe handling and international transport of hazardous wastes.

National Action Plan for Chemical and Waste **Management**

- Reflects India's commitments to the Stockholm and Rotterdam Conventions.
- According to the 2021 E-Waste Inventorisation Report, Tamil Nadu is the second-largest e-waste generating state in India.

'National Red List Assessment of Indian Flora and Fauna'

- India is set to conduct a first-of-its-kind assessment of nearly 11,000 species of plants and animals in India.
- Assess species' extinction risks to guide conservation measures.
- The exercise is expected to go on till 2030.
- Vision To establish a coordinated, science- (1) based red listing system that accurately reflects the conservation status of Indian species.
- Goal To publish National Red Data Books on flora and fauna by 2030, forming a central resource for conservation planning and threat mitigation.
- It follows IUCN Red List standards, the global benchmark for extinction risk assessment.
- International Commitments: Supports India's obligations under the Convention on Biological

Diversity (CBD) and Kunming-Montreal Global Biodiversity Framework (KM-GBF).

() Indian wolf (Canis lupus pallipes)

- The Indian wolf (Canis lupus pallipes), which has the oldest living lineage of the world's wolves, is likely to be classified as a new species by the International Union for Conservation of Nature (IUCN).
- Habitat: It is a denizen of scrubland and grasslands and inhabits semi-arid areas.

Conservation Status

- Likely to be classified as a distinct species by IUCN.
- Currently listed as "vulnerable".
- Included in Schedule 1 of the Wildlife Protection Act, offering legal protection.
- Conservation Model: Experts suggest the wolf, along with bustards and other species of open natural ecosystems serves as a "best model for co-existence" and does not require strict protected areas; this co-existence needs to be incentivized.

Kaziranga bird survey

- The Kaziranga National Park and Tiger Reserve recorded 146 species in the latest bird survey.
- The survey was conducted across five key locations - Agoratoli, Gamiri, Panbari, and Panpur ranges of the national park and the adjoining Laokhowa Wildlife Sanctuary.
- First of its kind in India: Focused exclusively on grassland bird species, often underrepresented in conventional bird surveys.

Kaziranga National Park

 It was established as a Reserve Forest in 1908 to protect the Indian rhinoceros, it became a Wildlife Sanctuary in 1950, National Park in

- 1974, and a UNESCO World Heritage Site in 1985. And it was declared as a Tiger Reserve in 2007 due to high tiger density.
- It is known for the Big Five: Rhinoceros, Tiger, Elephant, Asiatic Wild Buffalo, and Eastern Swamp Deer. Nearly the entire population of Eastern Swamp Deer is found here.
- It is located along the Brahmaputra River.

Forest cover increase - India ranks 9th alobally

- This information has been released according to a new report released by the Food and Agriculture Organization (FAO) of the United Nations.
- India's total forest cover has increased to 9th globally. Moreover, India has consistently maintained the 3rd position in the annual increase in forest cover.
- According to the report, the total forest cover of the world is 4.14 billion hectares. Of this, only five countries - Russia, Brazil, Canada, the United States and China - have more than half 2. The Shankaracharya Temple is built on the of the forest cover (54 percent).
- India ranks 9th, following Australia, the Democratic Republic of the Congo and Indonesia.
- India ranks third in the annual increase in forest cover between 2015 and 2025, with 1.91 lakh hectares.

Asia's key role

- The report also highlighted that the Asian continent's forest cover is playing a key role in reducing global deforestation.
- Asia is the only region to have recorded an increase in forest cover during the period 1990-2025.

Coastal Green Wall

- A large green wall will be built in Andhra Pradesh to protect the coastline from degradation.
- With Andhra Pradesh's 1,053 km long coastline facing increasing threats to livelihoods and property loss, the government has decided to build a five km wide 'Andhra Pradesh Great Green Wall' by 2030.
- According to official sources, the wall will be designed to protect over three million people by serving as a "living ecological shield" while promoting biodiversity, climate resilience and sustainable development.

Zabarwan forest range

- The Zabarwan Range is a short sub-mountain range between Pir Panjal and the Great Himalayan Range in the central part of the Kashmir Valley.
- Specifically, the range is known to be what overlooks the Dal Lake and holds the Mughal gardens of Srinagar.
- edge of the central part of the Zabarwan Range.
- The highest peak of this range is Mahadev Peak at 13,013 feet (3,966 m), which forms the distant background of the eastern mountain wall.
- On the northern slopes of the central part of the range, there are three Mughal gardens built by Emperor Shah Jahan.
- These include Chashma Shahi, Nishat Bagh and Shalimar Garden alongside the Pari Mahal (the fairy palace).
- The Dachigam National Park is the main feature of the range which holds the last viable population of Kashmir stag (Hangul) and the largest population of black bear in Asia.

Karur Incident

Disaster Management Act, 2005

- Introduction: A law enacted after the 2004 Tsunami disaster
- Objective: To integrate disaster prevention, preparedness, relief, and recovery.
- Chairman of the National Disaster Management Authority (NDMA) - Prime Minister
- Chairman of the State Disaster Management Authority (SDMA) - Chief Minister
- Chairman οf the District Disaster Management Authority (DDMA) - District Collector
- Emergency Funds National (NDRF), State (SDRF).

Legal Provisions Related to the High Court

- The total sanctioned strength of judges in the Madras High Court is 75, while the current number of judges is 56.
- Articles 214 to 231 of the Constitution deal with the appointment and tenure of judges.
- Based on the recommendations of the Collegium, the President appoints judges to the Supreme Court and High Courts.

Collegium:

- It is a body consisting of the Chief Justice and senior judges of the Supreme Court and the High Courts in India.
- It is responsible for recommending reviewing judicial appointments.

Contempt of Court

 According to the law, any act that undermines the authority of a court, disobeys its orders,

- or obstructs the administration of justice is considered contempt of court.
- Contempt of court is classified into two types.

Contempt of Courts Act - 1971

This Act was enacted based the recommendations of the H.N. Sanval Committee.

Civil Contempt:

 As per Section 2(b) of the Contempt of Courts Act, 1971, civil contempt occurs when a person wilfully disobeys any judgment, decree, direction, order, writ, or other process of a court, or wilfully breaches an undertaking given to the court.

Criminal Contempt:

 As per Section 2(c) of the Contempt of Courts Act, 1971, criminal contempt occurs when a person, through any form of publication such as writing, speech, signs, or visible representations, acts in a manner that disparages the court or undermines confidence in its judgments.

Constitutional Provisions:

- Article 129: The Supreme Court is a "Court of Record" and has the power to punish for contempt.
- **Article 215**: The High Courts of states are also "Courts of Record" and have the power to punish for contempt.

Mandal Commission

 The Mandal Commission was a commission that brought a significant turning point in India's reservation system.

Formation of the Mandal Commission:

• The commission was **established in 1979**. It

was constituted by the then Prime Minister Morarji Desai.

• **B.P. Mandal** served as the **chairperson** of the **U** • commission.

Purpose:

recommend reservations in jobs and To educational opportunities for socially and educationally backward classes (OBCs) in government services.

Recommendations (1980):

- 27% reservation should be provided for OBCs in total government jobs.
- This brought the total reservation to 49.5% (including SC/ST).
- The judgment in this case was delivered in 1992.

Preventive Detention Laws

- Article 19 of the Indian Constitution guarantees fundamental freedoms such as freedom of speech, expression, and action.
- Article 21 of the Indian Constitution protects life and personal liberty, which includes the right to dignity and a decent life.
- Articles 22(3)-(7) of the Indian Constitution specify certain exceptions under which a person can be placed under preventive detention without being proven guilty of a crime. These articles also detail the safeguards available to a person under preventive detention and empower Parliament to enact preventive detention laws.
- Article 22 provides protection against arbitrary arrest and detention in certain cases. It states that detained persons must be informed of the reasons for their detention and cannot be denied access to legal counsel. However,

preventive detention laws are exempted from some of these safeguards.

Article 22(4) states that a person cannot be detained under preventive detention for more than three months unless an advisory board consisting of judges of a High Court recommends that there are sufficient grounds for such detention

Judicial Decisions:

- In 2025, Dhanya M. vs State of Kerala (under KAAPA, 2007), the Supreme Court of India emphasized that the extraordinary powers of preventive detention must be exercised sparingly and in strict accordance with constitutional safeguards.
- In S.K. Nazneen vs State of Telangana (2023), the Court held that preventive detention is not justified if the case pertains only to a mere law and order issue.

Grama Sabha

• Chief Minister M.K. Stalin will address grama sabha meetings on October 11 through the Bharat Net-Tamil Nadu Fibrenet Corporation Ltd (Tanfinet) network, covering about 10,000 villages across Tamil Nadu.

Grama Sabha

- Gram Sabha is a body consisting of all persons whose names are included in the electoral rolls for the Panchayat at the village level. The term is defined in the Constitution of India under Article 243(b).
- The Constitution mentions that Gram Sabha exercises such powers and performs such functions at the village level as the Legislature of a State may, by law, provide.
- All eligible voters of the village can participate in the Gram Sabha.

• The decisions taken by the Gram Sabha cannot be annulled by any other body except itself.

SC Judgment on District Judges Eligibility

- Judicial officers with seven years of experience in the Bar before joining judicial service can now be appointed as District or Additional District Judges.
- Previously, only practising lawyers with seven years' experience were eligible for direct recruitment.
- Chief Justice Gavai reasoned that a lawyer does not cease to be a lawyer upon joining judicial service.
- Constitutional Basis: No eligibility restrictions under Article 233(2) for judicial officers already in service.
- Minimum age for appointment as District or Additional District Judge: 35 years as on the date of application - Constitution Bench.

Central Drugs Standard Control Organisation (CDSCO)

The Central Drugs Standard Control Organisation (CDSCO) has asked the State governments to submit a list of all cough syrup manufacturers in India.

Central Drugs Standard Control Organisation (CDSCO)

- It functions as India's national regulatory body overseeing cosmetics, pharmaceuticals, and >20th medical devices.
- Controller General of India (DCGI) overseeing pharmaceuticals and medical devices.
- It is assigned duties under Drugs and Cosmetics Act, 1940.
- The DCGI is situated within the Ministry of Health and Family Welfare and receives guidance from the Drug Technical Advisory

Board (DTAB) and the Drug Consultative Committee (DCC).

Functions of CDSCO

- Approval of new drugs and clinical trials
- Import Registration and Licensing
- License approving of Blood Banks, LVPs, Vaccines, DNA products & some Medical Devices (CLAA Scheme)
- Amendment to Drugs and Cosmetics Act and Rules
- Banning of drugs and cosmetics
- Grant of Test License, Personal License, NOCs for Export
- Testing of New Drugs
- Overnight and market Surveillance through Inspectorate of Centre Over and above the State Authority

Census 2027

- The Population Census will be completed in 2027, following a delay from its original 2021 schedule due to the COVID-19 pandemic.
- Census Phases (2026-2027): The main census exercise will be held in two phases:
 - Houselisting and Housing Schedule.
 - Population Enumeration.
- This will be India's first digital Census and the first to enumerate caste in independent India.

anniversary of the Right Information Act, 2005

- The CDSCO is organized with the Drug It was enacted in June 2005 and came into force in October 2005.
 - The act provides citizens the right to secure access to information under control of Public Authorities (PAs).
 - Coordinating agency: Department of Personnel and Training under Ministry of Personnel, Public Grievances and Pensions (MoPPG&P).

- India enacted the "Freedom of Information Act, 2002" in order to promote, transparency and accountability in administration.
- Later, RTI Act 2005 replaced the Freedom of Information Act. 2002.
- 'Raj Narayan v/s Uttar Pradesh Government': Supreme Court established the Right to information as a fundamental right under the Article 19 of Indian Constitution.
- Central and State Information Commissions: to oversee its implementation and address appeals regarding non-disclosure information.

The Central Information Commission (CIC)

 It is a statutory body in India, established under the provisions of the Right to Information Act (2005).

Composition of Central Information Commission (CIC)

- The Central Information Commission consists of a Chief Information Commissioner and not more than ten Information Commissioners.
- They are appointed by the President on the recommendation of a Committee consisting of:
- The Prime Minister as the Chairperson,
- The Leader of Opposition in the Lok Sabha, and
- A Union Cabinet Minister nominated by the Prime Minister.

Immigration and Foreigners Act, 2025

- This Act came into force on 1st September 2025.
- It consolidates India's immigration laws, strengthens penalties for forged documents, and enhances registration and monitoring of foreigners.

Election Commission of India

- The Election Commission of India (ECI) is autonomous constitutional authority responsible for administering central and state election processes in India.
- It was established on 25 January 1950 under the Constitution of India (celebrated as National Voters' Day).
- The Commission's office is located in New Delhi.
- It conducts elections to the Lok Sabha, Rajya Sabha, State Legislative Assemblies, and the offices of President and Vice President of India.
- The ECI does not oversee elections for Panchayats or municipal bodies in the states; separate State Election Commissions handle these, as provided by the Constitution.
- The President of India appoints the Chief Election Commissioner (CEC) and other Election Commissioners, including their terms of office and conditions of service, as per the Election Commission (Conditions of Service of Election Commissioners and Transaction of Business) Act, 2023.
- Part XV (Articles 324–329) of the Constitution deals with elections and provides for the establishment of the Election Commission to manage electoral processes.

Gender Equity in Courts

 Women constitute only 14% of judges in the High Courts and a mere 3.1% in the Supreme Court.

About India Justice Report (IJR) 2025

 It is a national periodic assessment that evaluates the capacity of India's justice system across four key pillars—police, judiciary, prisons, and legal aid. It ranks states based on their performance in these areas, using metrics

such as human resources, infrastructure, budgets, workload, and diversity.

Key Highlights from the India Justice Report 2025

- Judicial Backlog and Vacancies: Pending cases have exceeded five crore, with high courts and district courts facing vacancy rates of 33% and 21%, respectively.
- 15 judges per 10 lakh population; Law Commission (1987) suggested 50 judges per 10 lakh population.
- Judges in Uttar Pradesh, Himachal Pradesh, and Kerala have workloads exceeding 4,000 cases per judge.

States-Level Findings

- Large States (population above 10 million): Karnataka once again takes top position and Andhra climbs to second from fifth.
- Telangana, eleventh in 2019, has retained its third position.
- Tamil Nadu ranks 5th overall among large states but 1st in prison management
- Sikkim retains its 1st rank among small states and is the only one to meet the 33% women judges' benchmark in High Courts.

National Commission for Minorities

- It is an autonomous body established by the Government of India in 1992.
- It was created under the National Commission for Minorities Act, 1992
- Its primary objective is to monitor the implementation of safeguards provided to minorities under the Indian Constitution.
- also advises the Central and State Governments on issues related to the welfare and development of minorities.

- Initially, five religious communities were declared as minorities:
 - Muslims, Christians, Sikhs, Buddhists, Zoroastrians (Parsis)
- Later, in 2014, Jains were also declared as a minority community through an official notification.
- The six religious minority groups together constitute about 20% of the country's total population.

Protection of Children from Sexual Offences (POCSO) Act, 2012

- POCSO Act came into effect on 14th November 2012 which was enacted in consequence to India's ratification of the UN Convention on the Rights of the Child in 1992.
- It is the first comprehensive law in the country dealing specifically with sexual abuse of children
- It is administered by the Ministry of Women and Child Development.
- Small States (population up to 10 million): 2011 It was intended to protect children from sexual assault, sexual harassment and pornographic violations, as well as to establish Special Courts for such trials.
 - The Act defines a child as any person below the age of 18 years. The Act provides punishment as per the gravity of offence.

Prevention of Female Infanticide

- This practice was implemented by the British government in 1870 and was later clarified in 1952.
- Laws and Schemes
 - PCPNDT Act, 1994 prohibits sex-selective abortion.

- Cradle Baby Scheme (1992, Tamil Nadu) provides a mechanism for safe delivery of the girl child.
- Beti Bachao, Beti Padhao (2015) protects Particle 371C and educates the girl child.

Special powers under Article 371 of the Constitution

- Under Part XXI of the Constitution of India, grants certain temporary, interim and special powers to certain states.
- It has been a part of the Constitution since. January 26, 1950.
- However, Articles 371(A-J) were brought in through amendments through Article 368.

Article 371

- ItconcernsthestatesofMaharashtraandGujarat. According to this provision, the Governor of Maharashtra has the special responsibility of establishing separate development boards for Vidarbha, Marathwada and other parts of the state.
- The Governor of Gujarat has a similar responsibility for Saurashtra, Kutch and other parts of Gujarat.

Article 371A

- Under this provision, no Act of Parliament relating to the religious or social practices of the Nagas, their customary law and practice, including matters of civil and criminal justice, ownership or transfer of land and resources shall apply to Nagaland, unless the State Legislature passes a resolution to that effect.
- Furthermore, it gives the Governor 'special' responsibility' for law and order in the State.

Article 371B

 This is for the State of Assam, which was introduced in 1969. It allows the President to deal with the constitution and functioning of a Legislative Assembly consisting of members elected from the tribal areas.

- This applies to Manipur and was added to the Constitution in 1972. It provides for the constitution of a Assembly consisting of members of the Legislative Assembly from the hill areas of Manipur.
- It gives the Governor special responsibility to submit an annual report to the President on the administration of the hill areas.

Article 371D and E

- It contains special provisions for Andhra Pradesh and Telangana.
- The President can issue an order to provide equal opportunities and facilities to the people of different parts of Andhra Pradesh in public employment and education.

Article 371F

- It applies to Sikkim and states that the State Legislative Assembly shall have at least 30 members.
- The Governor has special responsibility to maintain peace and make equitable arrangements to ensure social and economic progress of various sections.

Article 371G

• It applies to Mizoram. It includes special provisions for the protection of religious and social practices, customary law and practices of the Mizos in Mizoram, as well as the administration of criminal and civil justice, except for the ownership and transfer of land.

Article 371H

 It gives special responsibility for law and order to the Governor of Arunachal Pradesh.

Article 3711

 It relates to Goa. It requires that the Goa Legislative Assembly shall have not less than a 30 members.

Article 371J

 It grants special status to the Hyderabad-Karnataka region (Kalyana Karnataka) and provides for the establishment of a separate development board for the region.

Lokpal

 The number of complaints received by the Lokpal has decreased sharply from a peak of 2,469 in 2022-23 to just 233 this year (till September).

About Lokpal

- It is a statutory anti-corruption body established under Lokpal and Lokayuktas Act, 2013.
- **Present Chairperson**: Justice Ajay Manikrao Khanwilkar.
- Composition: Consists of a Chairperson and up to 8 Members, with 50% being Judicial Members.
- At least 50% of total Members must be from SC, ST, OBC, Minorities, and women.
- **Term for members**: 5 years or till the age of 70 years.
- Appointment: Appointed by the President after obtaining the recommendations of a The outgoing CJI recommends their successor Selection Committee consisting of,
 - Prime Minister (Chairperson)
 - Speaker of Lok Sabha
 - Leader of Opposition / Leader of single largest opposition party in Lok Sabha
 - Chief Justice of India/Judge of the Supreme Court nominated by him/her

 One eminent jurist to be nominated by the President

53rd Chief Justice of India

- Chief Justice of India (CJI) B.R. Gavai has recommended Justice Surva Kant as his successor.
- Justice Surya Kant is currently the senior-most judge of the Supreme Court.
- He will become the 53rd Chief Justice of India (CJI).
- The recommendation was made under the Memorandum of Procedure (MoP) governing appointments of the CII and Supreme Court judges.
- CJI Gavai retires on November 24, 2025.

About Article 124

- The Constitution of India does not mention any procedure for appointing the CJI.
 - Article 124 (1) of the Constitution merely says, "There shall be a Supreme Court of India consisting of a Chief Justice of India."
- Clause (2) of Article 124 of the Constitution says that every Judge of the Supreme Court shall be appointed by the President.

Appointment of CJI

- The President appoints the CJI under Article 124(2) of the Constitution.
- based on seniority.
- The Union Law Minister forwards the recommendation to the Prime Minister, who then advises the President.
- As per the Second Judges Case (1993), the senior-most Supreme Court judge is appointed as the CJI.

 - Tamil Nadu, West Bengal, Kerala, Puducherry, Uttar Pradesh, Madhya Pradesh, Rajasthan, Chhattisgarh, Goa, Gujarat, Andaman & Nicobar Islands, and Lakshadweep.

Assam excluded

 No SIR in Assam for now, as the State goes to polls next year. • Reason: Assam has separate citizenship provisions under the Citizenship Act, and a citizenship verification process is underway under Supreme Court supervision.

Background

- Kerala, First phase of SIR: Conducted in Bihar, Madhya resulting in deletion of over 68 lakh names from electoral rolls.
 - Most States last held an SIR between 002–2004.
 - Current SIR aims to update and standardize voter addresses and correct discrepancies through voter mapping.



INDIAN ECONOMY

National Gross Domestic Product

- Suman Bery stated that there is a large gap between high-income and low-income states in the country's Gross Domestic Product (GDP).
- High-income states representing 26 percent of the country's population contribute 44 percent to the nation's GDP. At the same time, lowincome states representing 38 percent of the population contribute only 19 percent.
- Compared to 2017-18, total employment increased by 15 crore in 2022-23. This includes 8 crore agricultural women workers and 4 crore unpaid family workers, stated Suman Bery.
- Gross Domestic Product: The total monetary value of all goods and services produced within a country's borders during a specific period (generally 1 year).
- Types:
 - Nominal GDP At market prices.
 - Real GDP Adjusted for inflation.
 - Per capita GDP Average per person
- In India, the National Statistical Office (NSO) calculates GDP.

Asian Development Bank

- The Asian Development Bank (ADB) was established in 1966.
- Its headquarters is in Manila, Philippines.
- Objective: Economic development and social progress in Asian regions.
- Member countries: 68 countries (48 Asian and 20 other countries).

Benefits received by Tamil Nadu:

Births Decline and Deaths Slightly Rise in India

- According to the Vital Statistics of India 2023, based on the Civil Registration System, 86.6 lakh deaths were registered in 2023.
- This is a slight increase over the 86.5 lakh deaths registered in 2022.

Decline in Births

In 2023, 2.52 crore births were registered in India, which is approximately 2.32 lakh fewer than in 2022.

- This is likely to be implemented from January 1, 2026.
 - The Central Government has constituted the Pay Commission to revise the basic pay, dearness allowance, pension and other cash benefits of central government employees based on price rise and inflation and has been implementing pay hikes and dearness allowance hikes every 6 months on the basis of its recommendations.

New technology to produce seafood products

- The conference was held in Chennai.
- Efforts are being made to introduce a project in Tamil Nadu to set up fish farms in the sea itself and produce seafood products using modern technology.

Revenue Department Day - July 1

- The Tamil Nadu government has announced that July 1, which marks the beginning of the harvest season, will be celebrated as Revenue Department Day.
- The government issued this announcement in recognition of the excellent work and service of the Revenue Department.

Order issued to remove caste-based names from Tamil Nadu streets and roads

 The Municipal Administration and Water Supply Department of the Tamil Nadu government has issued an order to remove caste-based names from streets and roads.

- The department has released guidelines for removing or renaming residential areas, streets, roads, water bodies, and other public infrastructure that bear caste names.
- As an alternative to caste-based names, the Tamil Nadu government has suggested new names for ponds, water bodies, streets, and roads.
- Ponds and water bodies: The suggested names include Roja (Rose), Malli (Jasmine), Sembaruthi (Hibiscus), Sooriyakandhi (Sunflower), Saamanthi (Chrysanthemum), Thaazhampoo (Screw pine flower), Kandhal (Glory lily), Kanakambaram (Crossandra), Konrai (Cassia), Maghizhamboo (Mimusops elengi), Mullai (Jasmine), Senbagam (Michelia champaca), Kuvalai (Water lily), Kurinji, and Sevvanthi (Chrysanthemum).
- Streets and roads: The suggested names include Thiruvalluvar, Avvaiyar, Kapilar, Seethalai Saathanaar, Nakkeerar, Pisirandhaiyaar, Kambar, Agathiyar, Veeramamunivar, Bharathiyar, Bharathidasan, Mahatma Gandhi, Thanthai Periyar, Perarignar Anna, Kamarajar, and Kalaignar.

Tamil Nadu's Fourth Biodiversity **Heritage Site**

- The Nagamalai Hill in Erode district has been declared as Tamil Nadu's fourth Biodiversity Heritage Site by the Government of Tamil Nadu.
- This announcement was made by the State Department of Environment, Climate Change and Forests.
- Tamil Nadu has 20 Ramsar sites, the highest number in India.
- Biodiversity Heritage Sites are designated areas aimed at protecting rare, endangered,

- and threatened species, and promoting their conservation and breeding.
- Last year, Arittapatti in Madurai district was declared a Biodiversity Heritage Site, followed by Kaasampatti in Dindigul district and Elathur Lake in Erode district this year.

Naaamalai Hill

- The hill covers an area of 32.22.50 hectares.
- It serves as an important habitat for migratory and local birds, aquatic species, and wetland ecosystems.
- The hill is home to 138 plant species, 118 bird species, 7 mammals, 11 reptiles, 5 spiders, and 71 insect species.
- Rare bird species such as the Spotted Eagle, Pale Harrier, and Pennell's Eagle are also found here.
- The area also contains Iron Age stone circles, rock shelters, and ancient artefacts discovered by archaeologists.
- Additionally, a 400-year-old stone-carved idol of Anjaneyar Swamy (Lord Hanuman), registered by the Department of Archaeology, has been found in this region.

Mudhalvar Marundhagam Scheme

- This scheme was launched on 24-02-2024 by the Tamil Nadu Health Department.
- A total of 1,000 pharmacies are to be established across Tamil Nadu under this scheme.
- Under this scheme, medicines are sold at 25% less than the purchase price and up to 75% lower than the prices available in private pharmacies.

Seven-member High-Level Committee to Resolve Issues Related to Ryotwari Patta Lands

- Ryotwari land refers to lands directly granted by the government to individuals, particularly in the states of Tamil Nadu, Kerala, and Karnataka.
- To address issues related to Ryotwari Patta lands, the Tamil Nadu Government has constituted seven-member high-level committee.
- The Chief Secretary will serve as Chairperson of this committee.

Tamil Nadu Heritage Commission (TNHC)

- Madras High Court directed Tamil Nadu government to constitute the Tamil Nadu Heritage Commission (TNHC) within four weeks.
- TNHC is meant to protect age-old buildings and premises not covered under central or state ancient monuments laws.

Backaround

- TNHC Act enacted in 2012, but remained dormant for 12 years.
- Brought into force on March 12, 2024.
- Commission not yet constituted even after the law came into effect.

Composition of TNHC

- Chaired by an eminent person committed to heritage conservation.
 - Maximum 16 members, including exofficio members: **Tourism** Secretary, Urban Development Secretary, Municipal Administration Secretary, Rural Development Secretary, Law Secretary.

Ancient Monuments and Archaeological Sites and Remains Act - 1958

 This Act was created to protect, maintain and study ancient temples, monuments, antiquities, archaeological sites etc. in India.

Some places protected under this Act in **Tamil Nadu:**

- Pallava monuments of Mamallapuram
- Thanjavur Big Temple
- Tiruvannamalai Arunachaleswarar Temple
- Kanchipuram Gangaikonda Cholapuram
- Keezhadi Archaeological Site, etc.

ASI documents 10 Chola-era inscriptions

- The Epigraphy Division of the Archaeological Survey of India (ASI) documented Chola-era inscriptions rare the C Vedapureeswarar temple at Therazhundur in Mayiladuthurai district.
- Door jamb inscriptions in Tamil, 12th Century CE, from Kulottunga Chola I (34th & 44th regnal years).
 - Record grant of five kāsu to Brahmins for lighting lamps ('Tiruvilakku' 'Sandhivilakku').
- Mahamandapam inscriptions from Kulottunga Chola III record donations for Tirumanjanam and fines on defaulters.
 - One inscription from Rajaraja II records 20 donations for Nundavilakku.
- Temple belongs to the early period of imperial Cholas.

Tamil Nadu Launches Co-Creation Fund to Assist Start-up Initiatives

- Tamil Nadu government to launch a □100 crore co-creation fund to invest in venture capital funds that support local start-ups at the inauguration of the Global Startup Summit in Coimbatore on 9, October.
- Managed by Tamil Nadu Startup Innovation Mission (StartupTN).
- Aim: Create new Venture Capital firms in the State and attract global investment.

- It will strengthen Tamil Nadu's startup ecosystem and help achieve a \$1 trillion economy by 2030.
- According to the Global Entrepreneurship Index Report 2024, Chennai is ranked 18th at the Asian level.

Startup Growth in Tamil Nadu:

- Number of start-ups increased six-fold in four years: from 2,032 to 12,000.
- 50% of start-ups are women-led.
- Investment capacity grew from \$1 million (2016) to \$6 million (2024) per start-up.
- TN recognized as a model State by Atal Innovation Mission for innovation ecosystem.

TANSEED - Connecting Platform

 This scheme is being implemented to provide seed funding so that start-up companies in the initial stage do not give up their efforts due to lack of financial assistance.

'TAN Fund' - Connecting Platform

- An investor connecting platform called 'TAN Fund' has been launched with the aim of connecting entrepreneurial companies that need investment and investors.
- A primary action plan called 'Vision 2035' has been created to build Tamil Nadu as a suitable leading state for start-up companies.

Release of the Critical Anthology on Sahitya Akademi Award-Winning Works

- The event was organised by the Department of Tamil, D.G. Vaishnav College, Arumbakkam, Chennai.
- The works of 28 writers who had received the Sahitya Akademi Award were critically analysed by 28 professors 27 from the Tamil Department and one from the Sanskrit Department — and compiled into a collection of critical essays.

Sahitya Akademi Award

- It is a prestigious award presented annually by the Government of India at both the national and state levels.
- The award is given for outstanding literary works such as short stories, novels, literary criticism, and other forms of writing in twentyfour Indian languages.
- The award was first instituted and presented in the year 1954.

Mukurthi National Park (MNP)

- A radio-collared Nilgiri tahr fitted in December 2024 was killed by a tiger in Mukurthi National Park (MNP).
- The radio-collaring and monitoring is one of the nine components of the Project Nilgiri Tahr.
- It is located in the western corner of the Nilgiris Plateau in the northwest corner of Tamil Nadu.
- The park was created to protect its keystone species, the Nilgiri tahr.
- Pykara and Kundah rivers flow through the park along with several perennial streams that originate in the park and drain into the Bhavani Puzha.
- It is designated as the UNESCO World Heritage Site.
- The Park is characterised by montane grasslands and shrublands interspersed with sholas in a high altitude area of high rainfall.

Iron Age culture near the Western **Ghats in Tamil Nadu**

- The excavations confirm the presence of an Iron Age culture near the Western Ghats in Tamil Nadu.
- The culture is considered akin to those found at Adichanallur and Sivagalai.

- Tentative estimates place the site's date in the early to mid-third millennium BCE, similar to the dating of Adichanallur and Sivagalai (e.g., between 3,345 BCE and 2,513 BCE). The exact period awaits scientific analyses.
- A rectangular stone slab chamber with urn burials and urns was unearthed - a first-of-itskind discovery in Tamil Nadu. The chamber was made of 35 stone slabs and filled with cobblestones
- A rich collection of ceramics was found, including white-painted black-and-red ware, red ware, red-slipped ware, black-polished ware, and coarse red ware.
- The white-painted designs on black-and-red ware, black ware, and black-slipped ware are a unique feature shared with sites like Adichanallur and Sivagalai.
- Symbols on the urns were a significant discovery. One red-slipped pot had dotted designs showing a human figure, a mountain, a deer, and a tortoise.
- Significance: Provides evidence of Iron Age culture near Western Ghats, with features Adichanallur, comparable to Sivagalai, Thulukkarpatti, and Korkai.

Vidiyal Payanam Thittam

- 3.97 Crore people benefited from the freetravel Vidiyal Payanam Thittam.
- Started in the year 2021, the scheme was initially known as "Zero Ticket Bus Travel Scheme for Women".
- Through this scheme, the state government provides free bus travel to beneficiaries women across the Tamil Nadu.
- The primary objective of this scheme is to offer free bus travel to women and alleviate their financial burden.

Vidiyal Payanam Thittam to Differentlyabled People Living in Hilly Areas

- The Vidiyal Payanam Thittam (Free travel for (1) This scheme was launched in April 2024. women and now PwD) has been expanded . It was initiated by the Chennai Municipal to cover differently-abled persons (PwD) traveling in hilly areas.
- The Tamil Nadu government has issued the order for this extension.
- Beneficiaries: Differently-abled persons with 40% or more disability are eligible.
- One attendant accompanying the eligible differently-abled person is also permitted to travel free of charge.
- Applicable Route: Ordinary fare buses operating within a range of 35 km to 40 km in hilly regions and connected areas.
- The expansion was announced by the Chief Minister on August 15 (Independence Day).

Kalaignar's Dream Home Scheme

- This is a housing scheme launched by the Tamil Nadu government.
- The scheme was initiated in 2023 by the Chief Minister.
- It is implemented through the Tamil Nadu Slum Clearance Board and the Urban Development Department.
- The objective of the scheme is to ensure that every citizen receives a modern, well-equipped residence of their own.

Our Village, Our Government" Scheme

- This scheme was launched by the Chief Minister in 2024.
- Its purpose is to directly engage with the public to address their requests, complaints, and issues.
- It operates under the direct supervision of the Chief Minister's Office.

Scheme for Collecting Unused Items from Households

- Corporation.
- The objective of the scheme is to collect large unused items directly from homes so that they are not dumped on the streets, ensuring proper disposal from households themselves.

Establishment of International-Standard Colored Fish Trade Centre

- For the first time in India, this centre has been set up in Kolathur, Chennai. It was inaugurated by the Chief Minister on 11th October 2025.
- The centre is built on a land area of 15,945 square meters.
- This scheme was announced in the 2020–2021 Union Budget.

Safe Housing for Transgender Persons – "Aran Illam"

- On 13 October 2025, the Chief Minister launched a scheme called "Aran Illam", providing safe housing for transgender persons.
- Considering the social, mental health, and safety challenges faced by transgender individuals, special centers under this scheme will create secure, respectful, and dignified living environments.
- The first centers have been established in Chennai (Central Chennai) and Madurai (Anna Nagar).
- Transgender persons aged 18 and above, who are rejected by family, transgender, or intersex individuals, can stay in these centers from one week up to a maximum of three years. Each center can accommodate 25 residents at a time.

- The centers will also provide:
 - Guidance to start self-employment,
 - Financial assistance.
 - Support for filing complaints against violence or discrimination.
 - Free legal aid, and
 - Awareness programs on rights entitlements.

Inquauration of "Mission Mausam" Centre

- The "Mission Mausam" centre has been established by the Ministry of Earth Sciences using advanced technological instruments to study weather and environmental changes.
- The centre is located at Sathyabama Institute of Science and Technology, Semmancheri, Chennai.

About Mission Mausam:

- It was launched in 2024 by the Ministry of Earth Sciences.
- The mission aims to enhance weather and climate services.
- Through this initiative, accurate and timely models, and early warning information will be provided for multiple sectors such as:
 - Agriculture,
 - Disaster management, and
 - Rural development.

India Ranks First Globally in National Highway Connectivity

- The Minister of Road Transport and Highways stated that India currently ranks first globally in terms of national highway connectivity.
- In automobile production worldwide, the USA ranks first, China second, and India third.

- In Tamil Nadu, 50% of production from twowheeler manufacturing units is exported.
- Globally, India ranks fourth in the economy.

Mullaperiyar Dam

- The Mullaperiyar Dam is one of India's most important and historically renowned dams.
- It is located in the Idukki district of Kerala.
- However, the water from this dam is supplied to the state of Tamil Nadu.
- The dam is named "Mullaperiyar" because it is situated at the confluence of the Mullayar and Periyar rivers.
- The primary purpose of the Mullaperiyar Dam is to divert water from the west-flowing Periyar River eastward to supply water to the drought-prone regions of Tamil Nadu.

Startup Ecosystem in Tamil Nadu: Opportunities and Challenges"

- The Tamil Nadu State Planning Team's report titled "Startup Ecosystem in Tamil Nadu: Opportunities and Challenges" recommends that financial procedures for startups should be simplified, market access improved, and public procurement given importance.
- The report also states that if the government funding application process is made easier, more people are likely to apply for such support.

Kalaignar Magalir Urimai Thogai Thittam

- This scheme was launched by the Tamil Nadu government on 15 September 2023.
- The scheme aims to provide a monthly financial assistance of □1,000 to women who are heads of their households, with the goal of improving their livelihood and economic wellbeing.

Agreement between Tamil Nadu and Italy

- At the Frankfurt International Book Fair in Germany, an MoU was signed between Tamil U. It aims to conserve the "endangered" Dugong Nadu and the Bologna Children's Book Fair organization of Italy for literary and cultural exchange.
- On behalf of the Tamil Nadu government, 10-member delegation led Chandramohan, Principal Secretary of the School Education Department, participated and set up a special pavilion.
- Through this initiative, Tamil literary works are expected to reach readers across the world.

Australia's Interest in Partnership with **Tamil Nadu**

- The Government of South Australia has expressed interest in collaborating with Tamil Nadu and Chennai in the field of water management. Karleen Maywald, South Australia's Ambassador for Environment and Water, stated that they aim to share their expertise and innovative technologies through institutional and commercial partnerships.
- We are keen to share our knowledge gained in understanding the challenges of water management
- In Tamil Nadu, especially in Chennai. Our goal is to introduce innovative and cost-effective water management technologies to ensure safe drinking water supply," she said.

Dugong conservation centre

- The International Dugong Conservation Centre (IDCC) is proposed to be built at Sarabendrarajanpattinam village, Pattukottai taluk, Thanjavur district.
- The site is located within a No-Development Zone under the Coastal Regulation Zone (CRZ) guidelines.

- The IDCC is to be established under the TN-SHORE (Tamil Nadu Sustainably Harnessing Ocean Resources and Blue Economy) initiative.
- species, a marine mammal also known as "sea cow" and its habitat in the Palk Bay.
- Recognised by IUCN in 2025 as a pioneering step for marine biodiversity and communityled conservation.

About Dugong (Sea Cow)

- Key Feature: Only marine herbivorous mammals that depend on seagrass.
- Distribution: In India, apart from Palk Bay (highest), it is also found in Gulf of Mannar, Gulf of Kutch, etc.
- Status:
 - IUCN Redlist status: Vulnerable
 - Listed in Schedule I of the Wild Life (Protection) Act, 1972.

Tamil Nadu Global Start-up Summit (TNGSS) 2025

- The Tamil Nadu Global Start-up Summit (TNGSS) 2025, a major milestone in India's innovation landscape, was held in Coimbatore.
- summit highlighted Tamil Nadu's transformation into a leading hub for and entrepreneurship technology-driven innovation and demonstrated the state's commitment to empowering start-ups and investors.
- Tamil Nadu's registered start-ups saw a dramatic increase from 2,032 in 2021 to over 12,000 in 2025 (one of the fastest growth rates nationally).
- The summit was organized by the Tamil Nadu Start-up and Innovation Mission (StartupTN), a state agency under the Department of MSME, which provides funding, incubation, and mentorship.

- The 2025 summit's theme was "Disrupt to Rise," promoting bold innovation, transformative ideas, and breaking conventional models.
- The launch of the TNGSS app was a highlight, featuring AI-based matchmaking, scheduling, and personalized networking tools.
- Tamil Nadu aims to create one lakh direct jobs through start-ups by 2030 and reinforces the state's vision to build a self-sustaining innovation ecosystem.
- Coimbatore Known as the "Manchester of South India"; a key hub for technology and manufacturing start-ups.
- Tamil Nadu ranks among the top five Indian states in start-up registrations under DPIIT.

Kurinji Bloom in Gudalur

- The mass flowering of Kurinji after eight years in Tamil Nadu's newly notified Gudalur Reserve Forest in the Nilgiris signals biodiversity recovery and serves as an indicator of healthy grasslands and changing climate conditions.
- In Gudalur, the mass bloom is of another species of kurinji, Strobilanthes sessilis, which blooms once in eight years.
- Both are grassland species but isolated to different altitudes: neelakurinji occurs in grasslands of altitude above 1,300 metres, and sessilis in the lower altitudes.
- Over 60 species of Kurinji, including Neelakurinji (Strobilanthes kunthiana), are endemic to the Western Ghats, with 33 varieties in the Nilgiris.
- Kurinji species flower with different periodicities: annually (e.g., karinkurinji), four years, eight years, 10 years (over 20 species), and 12 years.

- Kurinji flowers once in a lifetime, like bamboo, and dies after flowering, relying on seed germination for the next generation.
- Color variations include purple, blue, white, and pink, with multiple shades for each.
- The Tamil Nadu government has notified over 90 new forest areas in the last four-and-a-half years to increase green cover.

Neelakurinii

- It is a shrub native to the shola forests of the Western Ghats. It is found in abundance in the Kodaikanal region of Tamil Nadu.
- The plant blooms once every 12 years and is classified as Vulnerable on the IUCN Red List.
- The Nilgiris ("Blue Mountains") get their name from its blue flowers.

Cultural Significance

- In local mythology, the Kurinji flower is associated with Lord Muruga.
- Among the Muthuvas and Todas tribes, Kurinji symbolizes love and passion.

Ecological Significance

- Kurinji blooms act as a natural indicator of climate and grassland health.
 - Mass flowering = sign of healthy grasslands.
 - Patchy flowering = result of ecological disturbance.

'Thozhi' Hostels

- 26 'Thozhi' hostels for working women are currently under construction across Tamil Nadu at various stages.
- Launch Date: January 4, 2024.
- Department: Social Welfare and Women Empowerment, Government of Tamil Nadu.

- affordable • **Aim**: To provide safe and accommodation for women working in various locations.
- Target Group: Women living far from families, belonging to lower and middle-income groups.

Tamil Nadu Natural Farming Project

- The Tamil Nadu Natural Farming Project was recently launched at the Epic (Eco Park and Information Centre) in Padur, off Rajiv Gandhi Salai.
- Members of Self-Help Groups (SHGs) from four clusters in three districts are being trained: Chengalpattu, Tiruvallur, and Kancheepuram.
- The initiative is a pilot project for the future implementation of natural farming techniques across the State. Each cluster will cover five villages.
- Farmers are being trained in natural farming under the National Rural Livelihoods Mission

Core Principles of Natural Farming:

- It is neither organic farming nor conventional farming that relies synthetic fertilizers and pesticides.
- It supports year-round crop cultivation (continuous production).
- It involves growing pest-attractant plants to safeguard main crops.
- Seeds for the next crop are collected from the previous crop (use of indigenous seeds).
- The top soil is disturbed minimally to keep microbes intact.
- Biostimulants are encouraged as catalysts for plant growth.
- Benefits/Approach: The system involves the use of indigenous seeds, integration of animals

into farming, reduction in cultivation costs, and assurance of a regular income for farmers.

First phase of archaeological survey off Poompuhar coast completed

- Conducted by: Tamil Nadu State Department of Archaeology (TNSDA) in collaboration with trained divers from Indian Maritime University.
- **Location**: Off the coast of Poompuhar (Kaveripoompattinam), Mayiladuthurai district.
- **Objective**: The primary aim was to identify potential archaeological remains of the ancient Sangam-era port city submerged in the Bay of Bengal.
- Survey Duration: The survey lasted for 12 days, beginning on September 20.
- Technology Used: Advanced marine exploration instruments were used to map the ocean floor and detect structural anomalies, including a remotely operated vehicle, side-scan sonar, sub-bottom profiler, and multibeam scanner.
- Logistics: The operation was supported by local fishermen using mechanized boats and smaller fibre boats.
- Historical Reference: The team traced several underwater locations previously identified by veteran archaeologist S. R. Rao, who conducted a similar survey nearly three decades ago.

Chief Minister's Breakfast Scheme

- The scheme was launched on 15 September 2022 (Periyar's birthday).
- Expansion: All Tamil Nadu government and government aided schools, classes 1-5

Special feature:

- First such scheme at the state level in India
- Appreciation by organizations including UNICEF

Expired Vehicle 'Scrapping' Scheme

- As part of the measures to reduce air pollution, a scrapping scheme to destroy old vehicles will soon be launched in Tamil Nadu.
- In addition, 8 out of 100 families use cars. The number of vehicles is increasing faster than the population of the country.
- Poor roads, fuel quality, use of old vehicles and improper traffic management are the main factors responsible for air pollution. Studies have shown that old vehicles are the most affected.
- The scrapping company itself will pay the appropriate amount to the vehicle owners. Once the scrapping of vehicles is completed, its registration number and all the documents of the vehicle will be uploaded on the website of the transport department.

Green Power Generation - Tamil Nadu

- Tamil Nadu ranks fourth in green power generation with a power generation capacity 20 of 26,588 MW in September.
- The Central Government has advised all states to increase power generation through (1) renewable green energy sources to achieve environmentally friendly and sustainable power generation.
- In this situation, the Central Government has also released the power installation capacity list as of September.

- The scheme will be implemented for a period of three years.
- The money will be allocated from the Sixth State Finance Commission.
- The programme will begin in Chennai and later be expanded to other urban local bodies in a phased manner.

Tamil Nadu tops the list in spiritual and medical tourism

- The 4th Tamil Nadu State Tourism Awards ceremony was held in Chennai on behalf of the Tamil Nadu Tourism Department.
- In this, 52 institutions and individuals were awarded state tourism awards in 17 categories by the Tamil Nadu Government.
 - The Ministers of the Public Welfare Department have said that Tamil Nadu has topped the list in spiritual and medical tourism in India at this ceremony.

 They have also said that work is being done at a cost of Rs. 705 crore to develop tourist destinations across Tamil Nadu.

Government Honors for Organ Donors Scheme

- The Tamil Nadu government has been honouring the bodies of organ donors since August 13, 2019.
- The aim of this is to express the gratitude of the society to those who save the lives of others through life donation.
- The Tamil Nadu government flag will be draped over the body.
- Through this, the government is honouring the humanity and selfless sacrifice of organ donation.
- Tamil Nadu is the leading state in organ donation in India

Marudhu Brothers

- The Maruthu Pandiyar brothers were publicly hanged on October 24, 1801, at the Tirupputhur fort, Sivaganga in southern Tamil Nadu.
- Marked the end of the South Indian Rebellion (1800-1801) - one of the earliest organized resistances against British rule, predating the 1857 Revolt by over 50 years.
- About Maruthu Pandiyar Brothers
- Periya Maruthu (1748–1801) and Chinna Maruthu (born c.1753) - sons of Mokka Palanisamy Thevar and Ponatha.
- Served under Muthuvaduganatha Thevar, the second king of Sivaganga.
- Gained royal favor after saving the king from a tiger, earning the title "Pandiyar."

- On June 16, 1801, months before their death, the brothers issued a Proclamation of Independence from the Tiruchi fort.
- Called for all Indians, irrespective of caste or community, to unite against European domination.
- Recognized by historians as the first all-India call for independence.

Heatwave

- The Tamil Nadu government has officially declared heatwaves a State-specific disaster.
- The government will use the State Disaster Response Fund to support these relief efforts
- Tamil Nadu ranks fifth among Indian States with high to very high heat risk, according to a Council on Energy, Environment and Water (CEEW) study.
- Heat wave is considered if maximum temperature of a station reaches at least 40°C or more for Plains and at least 30°C or more for Hilly regions.

Thevaram-inscribed copper plates

- A total of 483 copper plates bearing Thevaram hymns and 23 panchaloha idols of various deities were unearthed.
- They were discovered in April 2023 at the Thoniappartemple (also known as Sattainathar temple) in Sirkazhi, Mayiladuthurai district.
 - This is the first time copper plates inscribed with Thevaram hymns have been discovered in Tamil Nadu.
- The finding validates stone inscriptions in the **Chidambaram temple** that mention the practice of inscribing Thevaram hymns on copper plates.

- Considered a rare and historic find for Tamil Shaivite literature.
- temples and were composed by Shaivite Thirunavukkarasar saint-poets (Appar), Thirugnanasambandhar, and Sundarar.
- The style of writing suggests the inscriptions were made by various individuals, not a single scribe.
- So far, the deciphered hymns match known Thevaram verses — no new hymns have been identified yet.
- The study and compilation are being conducted by the Tamil Nadu State Department of Archaeology (TNSDA), led by Joint Director R. Sivanantham.

Tamil Nadu Election Commission

- The Tamil Nadu State Election Commission is an independent political body formed to conduct local government elections in the state.
- It is responsible for conducting Panchayat, Municipal and Corporation elections in a fair and orderly manner.
- It was formed by the Tamil Nadu Panchayats Act, 1994 and the Tamil Nadu Municipal Laws Amendment Act, 1994.
- Its head office: Located in Chennai
- Chairman: Tamil Nadu State Election Commissioner (Jothi Nirmala Samy), who is appointed by the Governor of the state.
- Articles 243K and 243ZA of the Constitution of India provide the legal basis for the establishment of the State Election Commission.

Innuyir Kaappom Thittam has been extended

- The hymns are about Lord Shiva of various The government has given permission to implement the Innuyir Kaappom Thittam - Nammai Kaakkum 48' scheme under the insurance scheme till January 2027.
 - This scheme was launched on January 18, 2020 - by the then Tamil Nadu Chief Minister Edappadi K. Palaniswami.
 - Implementing body: The Tamil Nadu Health and Family Welfare Department
 - Aim: Preventing deaths due to road accidents, the government has decided to implement a scheme to provide advanced treatment to the injured for the first 48 hours.
 - Under this, steps have been taken to provide 101 types of life-saving treatments worth up to Rs. 2 lakh free of cost in private and government hospitals.
 - For this, this scheme was connected to 723 private and government hospitals across the state.

Suchindram Theroor Wetland

- Suchindrum Theroor Wetland complex is part of the Suchindrum-Theroor Manakkudy Conservation Reserve.
- One of the two Ramsar sites in Kanniyakumari district.(Another one - Vembannur Wetland Complex)
- It is declared an Important Bird Area (IBA) and lies at the southern tip of the Central Asian flyway of migratory birds.
- Home to Birds: Hosts species like blackheaded ibises, egrets, little egrets, cattle egrets, grey herons, little cormorants, night herons, painted storks, and pelicans.

- Copper plate inscriptions from the 9th century mention Pasumkulam, Venchikulam, Nedumarthukulam, Perumkulam, Elemchikulam and Konadunkulam.
- Tamil Nadu has 20 Ramsar sites, which is the highest number in India.

Oil spill crisis management plan

- The Government of Kerala has decided to prepare a comprehensive Oil Spill Crisis Management Plan to prevent and mitigate the impact of oil spills along its coastline.
- Kerala has a 590-km-long coastline along the west coast of India.
- The plan will be aligned with the National Oil Spill Disaster Contingency Plan (NOSDCP).
- Kerala, following Tamil Nadu's example, is developing an oil spill crisis management plan under Defence Ministry guidance.
- Nodal Ministry: Ministry of Defence (MoD)
 (For handling crises arising out of the spill of oil and hazardous substances at sea)

Tamil Nadu State Oil Spill Disaster Contingency Plan (TN-SOS-DCP)

- Introduced in January 2024 following an oil spill in Ennore, Thiruvallur district.
- Goal: To prevent and mitigate the impact of future oil spills and restore contaminated habitats.
- Very High-Risk: Ramanathapuram, Thoothukudi, Gulf of Mannar islands, Thiruvallur
- High-Risk: Kanniyakumari and Chennai
- The plan focuses on 15 sensitive zones, which need special attention and quick action if an oil spill happens.

 Nodal Agency: Tamil Nadu State Disaster Management Authority (TNSDMA)

Indian Efforts for Oil Spill Management

- National Oil Spill Disaster Contingency Plan (NOS-DCP)
 - The Indian Coast Guard (ICG) is responsible for maintaining and implementing the Plan.
 - It was promulgated in 1996 and revised in 2015.
- Merchant Shipping Act, 1958:
 - Grants the government authority to enforce compliance with shipping regulations to prevent oil spills.

Control Measures for Oil Spills

- Bioremediation: Using microorganisms to remove toxins (e.g., TERI's Oil Zapper bacteria).
- Oil Booms: Floating barriers to contain spills.
- Offices Guara, Dispersants: Chemicals sprayed to aid natural
 Since 201 oil breakdown.

'Nalam Kaakum Stalin' Scheme

- The scheme was launched in July 2021
- It operates under the direct control of the Chief Minister
 - It is a scheme launched by the Government of Tamil Nadu to protect the welfare of the public and resolve immediate issues and demands.
- Purpose: To directly listen to the problems of the people and find solutions. To ensure that government departments are functioning effectively. The aim is to increase the trust of the administration by interacting directly with the people.

Tamil Nadu tops in higher education

- Tamil Nadu is the state with the highest number of higher education graduates in • India, the Tamil Nadu Higher Education Minister has said.
- The pass percentage in higher education in India is 28.
- But this percentage has gradually increased to 45.69 in Tamil Nadu and now it is 75 percent.
- Tamil Nadu Initiatives: Naan Mudhalvan and Scheme. Educational Innovation Development Project, Pudumaipenn Project, Tamil Pudhuvan Project, Kalloori Kanavu Project, Free education for first generation graduates.

Future Ready Project

- The Future Ready Project is currently being implemented to prepare government school students for the learning achievement exams, and the Tamil Nadu School Education Department has issued guidelines for it.
- The Future Ready Project has been implemented to improve the ability of government school students to face higher order thinking questions and learning achievement exams.
- Accordingly, in the first week of every month, students from classes 1 to 9 studied English, Mathematics, Science and subject-specific general knowledge. Higher order thinking questions and exams are to be conducted based on learning outcomes.

Makkalai Thedi Maruthuvam Scheme

- Started: 05 August 2021 (Krishnagiri)
- Objective : To provide home-based medical services to improve and treat conditions

Tamil Nadu's Maritime & Shipbuilding **Policy**

- Tamil Nadu is formalizing a comprehensive Maritime and Shipbuilding Policy.
- The policy is designed to incentivize new shipyards, attract global players, and enable equity partnerships between the State and private industry.
- The state is specifically targeting a "big thrust" toward two sectors: life sciences and shipbuilding.
- The state aims to transform its 1,000-km coastline into a corridor of "immense blue economy opportunities."

Tamil Nadu Pollution Control Board (TNPCB)

- The Tamil Nadu Pollution Control Board (TNPCB) was established on February 27, 1982, as the Tamil Nadu Prevention and Control of Water Pollution Board under the Water (Prevention and Control of Pollution) Act, 1974 (Central Act 6 of 1974).
- It was renamed as the Tamil Nadu Pollution Control Board in 1983.

- The TNPCB is responsible for enforcing the provisions of:
 - The Water (Prevention and Control of Pollution) Act, 1974
 - The Air (Prevention and Control of Pollution) Act, 1981
- The Environment (Protection) Act, 1986

Tamil Nadu's plan to develop coastal tourism circuits

- The Tamil Nadu government plans to develop coastal tourism circuits in Nagapattinam, Rameswaram, and Kanniyakumari to promote maritime and coastal tourism.
- The Nagapattinam Cruise Terminal is already functional.
- Plans are underway to link Poompuhar, Nagapattinam, Velankanni, and Kodiyakarai through a ferry service to enhance tourist connectivity along the coast.
- A ferry service between Rameswaram and Thalaimannar (Sri Lanka) is being considered the shortest sea route between India and Sri Lanka.

The initiative will be undertaken coordination with the Tourism Department for holistic coastal development.

First-Ever Air Shipment of GI Tagged Indi and Puliyankudi Limes

 The Agricultural and Processed Food Products Export Development Authority (APEDA) facilitated the first-ever air shipment of GItagged Indi Lime (Karnataka) and Puliyankudi Lime (Tamil Nadu) to the United Kingdom.

Puliyankudi Lime (Tamil Nadu)

- It is extensive lime cultivated in Pulivankudi, often referred to as the "Lemon City of Tamil Nadu."
- The Puliyankudi Lime, particularly Kadayam variety, is characterised by its thin peel, strong acidity, high ascorbic acid content (34.3 mg/100g) and juice percentage of around 55%.
- It is rich in Vitamin C and antioxidants.
- It has officially received the Geographical Indication (GI) tag in April 2025.

India as a Global Data Hub

- India possesses the second-largest telecommunications market in the world and has become one of the five countries globally capable of manufacturing telecom equipment domestically.
- The Prime Minister stated that India has achieved self-reliance in the telecommunications sector.

Brahmaputra River

- The Brahmaputra River originates from the Chemayung-Dung Glacier in the Kailash mountain range of Tibet.
- In Tibet, it is known as Tsangpo or Yarlung Tsangpo.

- Entering India through Arunachal Pradesh, it is called Siang, and in the state of Assam, it is known as the Brahmaputra.
- **Length of the river**: Approximately 2,900 km.
- Main tributaries: Dibang, Lohit, and Subansiri.
- In Bangladesh, it is called the Jamuna, where it joins the Ganga (Padma) and together they form the **Meghna**, which flows into the **Bay of Bengal**.

Menstrual Leave Policy

Border Security Force (BSF)

- It is one of the seven Central Armed Police Forces (CAPFs) of India, established in December 1965.
- It was created after the 1965 war with the objective of securing India's borders.

- It is the only CAPF that has its own Water Wing, Air Wing, and other support units.
- The Headquarters of the BSF is located in New Delhi.
- It functions under the Ministry of Home Affairs (MHA).
- The BSF is responsible for guarding and maintaining security along a 6,386.36 km stretch of the India-Pakistan and India-Bangladesh borders.

UN Troop Contributing Countries (UNTCC) Chiefs Conclave

- India will host the United Nations Troop Contributing Countries (UNTCC) Conclave in New Delhi from October 14-16. 2025, at the Manekshaw Centre.
- The conclave aims to enhance global cooperation and dialogue on UN peace operations.
- Army chiefs from over 33 nations to attend, mainly from the Global South and Europe.

India's Role in UN Peacekeeping:

- India's participation has evolved from a passive observer to an active stabiliser in global conflict zones.
- The country remains one of the largest troop contributors to UN peacekeeping missions.
- Currently, around 5,500 Indian personnel (men and women) serve in nine countries under UN mandates.

Google AI Center in Andhra Pradesh

 A \$15 billion (approximately Rs.1.33 lakh) crore) Artificial Intelligence data center is planned to be established in Visakhapatnam, Andhra Pradesh.

• The agreement for this project was signed in a meeting held in New Delhi, in the presence of the Union Finance Minister, the Chief Minister of Andhra Pradesh, and Thomas Kurian, CEO of Google Cloud Services.

Domestic Maritime Industry

- The 4th India Maritime Week will be held in Mumbai, Maharashtra from 27 October for five days.
- The Union Minister of Ports, Shipping and Waterways stated that the event is expected to attract investments of up to Rs.80 lakh crore.

Bathukamma festival

- Bathukamma is a nine-day floral festival celebrated by the women of Telangana to pay tributes to Mother Nature and celebrate the intrinsic bond between earth, water, and humankind. It marks the start of the winter season.
- Observed according to the Satavahana calendar, the festival begins on Bhadrapada **Purnima** (Mahalaya Amavasya/Pitru Amavasya) and concludes on Durgashtami, typically falling in September or October.
- Features folk songs, rhythmic clapping, and dance celebrating Telangana's cultural identity.
- This year, Telangana set a Guinness World Record with a 63-foot-tall Bathukamma crafted with 13 tonnes of flowers.

Azad Hind Government

 Azad Hind Fauj or the India National Army (INA) was first established by Mohan Singh in 1942. It was revived by Netaji Subhas Chandra Bose on October 21, 1943, during the

Second World War to secure India's complete independence from British Raj.

- Hence, every year on 21 October, the ① Ministry of Electronics and Information anniversary of the formation of Azad Hind Government is celebrated across the country.
- On this day, India's first independent provisional government named Azad Hind Government was announced.
- Under the provisional Government, Bose was the Head of State, Prime Minister, and Minister of War.
- Captain Lakshmiheaded the women's while SA headed organisation Aver the publicity wing in the newly formed government.
- Revolutionary leader Ras Behari Bose was designated as the supreme adviser by Netaji Subhash Chandra Bose.
- The government was supported by the Axis powers of Imperial Japan, Nazi Germany, the Italian Social Republic, and their allies.
- The Azad Hind government under Bose had in fact started its own bank, currency, civil code, and stamps.
- Bose had even formed the first women's regiment of the INA, the Rani Ihansi Regiment, thus laying the foundation for equal opportunity for women in armed forces.

MeitY announces Rs.5,532 crore investments in TN, AP, and MP

- Technology (MeitY) announced seven projects worth Rs.5,532 crore under the Electronics Component Manufacturing Scheme (ECMS).

- PMDDKY operates under the Ministry of Agriculture and Farmers' Welfare, each selected district will set up a District Dhan-Dhaanya Krishi Yojana (DDKY) Samiti, chaired by the District Collector, to implement the District Agriculture Development Plan (DADP).

Kavach System

- Kavach is a Train Collision Avoidance System (TCAS), a train control system with collision prevention features.
- It has been adopted as India's national automatic train protection system.
- The system adheres to safety interoperability standards.
- Acting like a "vigilant guardian" over the existing signaling system, Kavach alerts the Loco Pilot if the train approaches a red signal, and, if necessary, automatically applies brakes to prevent a signal overshoot.
- In emergency situations, the system can send SoS (Save Our Soul) messages.
- It also provides centralized real-time monitoring of train operations through the Network Monitor System.
- The Indian Railways Signal Engineering and Telecommunication Kavach Centre of Excellence is located in Secunderabad, Telangana.
- Currently, the Kavach train protection system
 has been installed in 1,200 train rakes.

India–Japan R&D Collaboration Support

- The year 2025 is being celebrated as the India-Japan Year of Science, Technology, and Innovation Exchange.
- This marks 40 years of long-standing collaboration between the two countries in research and development across multiple sectors

New Law to Strengthen Drug Quality Testing

- The Central Government plans to introduce a new draft legislation titled the Drugs, Medical Devices and Cosmetics Bill, 2025 during the upcoming winter session of Parliament.
- This new law is intended to replace the Drugs and Cosmetics Act, 1947, aligning India's drug regulatory standards with international norms.

Drugs, Medical Devices and Cosmetics Bill, 2025

 This Bill has been designed to replace the existing framework established in 1940, with the aim of ensuring the quality and safety of drugs and medical devices.

Drugs and Cosmetics Act, 1940

- The Drugs and Cosmetics Act, 1940 regulates the quality, safety, and standards of drugs, cosmetics, and medical devices in India.
- It serves as the foundation of drug regulation in India, overseeing quality control, manufacturing, and marketing.
- This Act, officially titled the Drugs and Cosmetics Act, 1940, was followed by the Drugs and Cosmetics Rules, 1945.
- Its objective is to ensure the quality, safety, production, and sale of drugs, cosmetics, and medical equipment.
- It enforces regulatory mechanisms to guarantee consumer protection and product quality assurance.

Gaganyaan Mission

 ISRO is actively working to implement India's dream project, Gaganyaan, by 2027, which

- aims to send humans into space, according to its chairman V. Narayanan.
- Over 80,000 tests have been conducted so far, and three rockets are to be launched for testing purposes.
- Globally, India currently contributes about 2% to the commercial use of rockets for space launches.

Indian Space Research Organisation (ISRO)

- India was driven to develop its own launch vehicles during the 1960s and 1970s.
- As a result, ISRO was established in 1969 with its headquarters in Bengaluru.
- In 1975, India's first satellite, Aryabhata, was built by ISRO and launched by the Soviet Union.
- In 1980, India launched its first satellite Rohini using an indigenous launch vehicle. Later, ISRO developed two major launch vehicles PSLV (Polar Satellite Launch Vehicle) for polar orbits and GSLV (Geosynchronous Satellite Launch Vehicle) for geostationary orbits.
- Its major milestone was the launch of Chandrayaan-1 in 2008, India's first mission to the Moon.
- ISRO operates through five research centres, two testing facilities, five construction and launch centres, four control centres, two human resource development units, and one commercial branch.

Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY)

 Women account for 49% of total hospital admissions under the AB-PMJAY, indicating improved access to institutional healthcare for women.

- Scheme Coverage
- Launched in 2018, it is one of the largest health insurance schemes globally.
- It provides a health cover of □5 lakh for a family every year.
- 35 States and Union Territories are under the AB-PMJAY umbrella (except West Bengal).
 Odisha and Delhi were recently onboarded.
- 15.14 crore eligible families covered under AB-PMJAY.
- An additional 8.57 crore families covered under State-specific schemes.
- Ayushman Card Issuance: Over 40.45 crore Ayushman cards have been issued, covering 14.69 crore families.

Inclusivity Initiatives:

- The Aapke Dwar Ayushman (ADA 3.0) initiative uses technology-led, communitybased self-registration.
- The 2023 interim Budget included 37 lakh families of frontline workers (ASHAs, Anganwadi workers, and helpers).
- In October 2024, the scheme was expanded to include all citizens aged 70 and above, regardless of income or socio-economic status.

PM Shri Scheme

 It is a central government scheme announced by the Prime Minister in September 2022 with

- the aim of improving the quality of school education in India.
- Under this scheme, which aims to create model schools based on the National Education Policy-2020, more than 14,500 schools operating under the control of central, state and local governments are to be upgraded.
- Through this scheme, central, state and local government schools in the country will be converted into model schools and modern educational facilities will be provided.

Gyan Bharatam Mission

- The Gyan Bharatam Mission will sign Memorandums of Understanding (MoUs) with approximately 20 institutes immediately (25, October 2025), and 30 more over the next few days.
- Key institutes involved include: Asiatic Society Kolkata, University of Kashmir (Srinagar), Hindi Sahitya Sammelan (Prayagraj), and Government Oriental Manuscript Library (Chennai).

About the Gyan Bharatam Mission

- The Gyan Bharatam Mission is a national initiative to preserve and digitise manuscripts, reviving them as living resources for education, research, innovation, and diplomacy.
- It was announced in the Union Budget 2025-26.
- Nodal Ministry: Ministry of Culture.
- The mission's mandate is to preserve and establish a dedicated digital platform known as the National Digital Repository (NDR) to share India's manuscript heritage worldwide.

• The Gyan Bharatam Mission aligns with Article 51A(f) of the Constitution, which makes preserving the rich heritage of our composite oculture a fundamental duty.

Subansiri Lower Hydro Electric Project (SLHEP)

 The first of eight units of the 2,000-MW Subansiri Lower Hydroelectric Project has begun undergoing a test run, signaling its imminent commissioning.

About Subansiri Lower Hydro Electric Project (SLHEP)

- It is an under-construction gravity dam on the Subansiri River in North Eastern India on the borders of Arunachal Pradesh and Assam.
- It is a run-of-river project.
- It will be the single largest hydroelectric plant in India when completed.

About The Subansiri River

• The Subansiri River is a trans-Himalayan river and the largest tributary of the Brahmaputra River that flows through Tibet's Lhuntse County in the Shannan Prefecture, and the Indian states of Arunachal Pradesh and Assam.

Great Nicobar Island Project

- The GNI Project, conceived by NITI Aayog and launched in 2021, aims to build an International Container Transshipment Terminal (ICTT), a Greenfield international airport, a township, and a gas-solar power plant.
- Nodal Agency: Andaman and Nicobar Islands Integrated Development Corporation (ANIIDCO), incorporated in 1988 as a

Government Undertaking under the Companies Act 1956.

Project Components:

- He is a former Director of the Tamil Nadu Archaeology Department and a historian.
- Born in Thoppalakkuppam, Virudachalam Taluk, Cuddalore District.
- Tamil the Nadu Archaeology Department in 1967 as an epigraphist. Served as Deputy Director in 1981 and Director in 1989 of the Tamil Nadu Archaeology Department.
- Founded the organization "Tamil Nadu Thonmai Iyala Ayvu Nilayam" and has conducted several seminars.
- Has conducted extensive research in Tamil inscriptions, archaeology, history, excavation, numismatics and manuscripts, and authored several books.
- Recipient of numerous awards, including the Tamil Nadu U.Ve.Sa. Award. Under his leadership, Tamil Nadu's first deep-sea **exploration at Poompuhar** was conducted.
- Donated over 3,000 documents, including his books and journals to the Raja Muthiah Research Library.

Commemoration of Veerapandiya Kattabomman-17.10.1799

- Veerapandiya Kattabomman from was Panchalankurichi.
- He was born in 1760. Father: Jegaveerapandian; Mother: Aarumugathammal; Wife: Jakkammal.
- Siblings: Sevathaiya, Oomathurai (real name: Kumaraswami).

- Veerapandiya Kattabomman was
 a Palaiyakkarar (chieftain) from
 Panchalankurichi, Tuticorin district of Tamil
 Nadu (then part of Tirunelveli).
- He was also called Kattabomman Nayakar of the Palaiyam. He was born to Jegaveerapandiya Kattabomman and Aarumugathammal. His reign began on February 2, 1790.
- In some parts of South India during the Vijayanagar Empire, local chieftains (Palaiyakkarars) were appointed as military leaders and administrative governors. They were responsible for a Palaiyam (territorial unit), hence called Palaiyakkarar (or the anglicized version, Polygar).
- Palaiyakkarars collected taxes from farmers and over time functioned as semi-independent rulers.
- Conflict began with the East India Company when they sought to control the Palaiyakkarars, collect taxes, and dominate the region.
- Kattabomman resisted the British and led a fight against them, which is known as the Polygar Wars, starting from 1799.

150th birth anniversary of Sardar Vallabhbhai Patel

- National Unity Day, or Rashtriya Ekta Diwas, is celebrated on October 31 in honour of Sardar Vallabhbhai Patel.
- Location: Ekta Nagar (near Kevadia, Gujarat), the site of the Statue of Unity, nestled between the Satpura and Vindhyachal mountain ranges.
- Sardar Patel's Statue of Unity, inaugurated in 2018, has the theme "Unity in Diversity."

About Sardar Patel

- Freedom fighter, statesman, India's first
 Deputy Prime Minister and Home Minister.
- Known as the "Iron Man of India" for his role in uniting princely states.
- Born in: October 31, 1875, in Nadiad, Gujarat, into a humble Lewa Patidar agricultural family.
- Deeply influenced by Mahatma Gandhi during Kheda Satyagraha (1918).
- Rose as a mass leader through Bardoli
 Satyagraha (1928), earning the title Sardar.
- Architect of Integration of 562 princely states into the Union of India, reducing them to 26 administrative units

Pasumpon Muthuramalingar - Birthday Celebration

- Full name: Ukrapandi Muthuramalingar
- Born: October 30, 1908 Pasumpon,
 Ramanathapuram district
- Died: October 30, 1963
 - Freedom fighter, patriot, and politician from Tamil Nadu.
 - Initially active in the Indian National Congress; later joined the All India Forward Bloc (AIFB) founded by Subhas Chandra Bose.
 - Supported the leadership of Subhas Chandra
 Bose and his policy of complete independence.
 - Served as a Member of Parliament from Ramanathapuram constituency.
 - He held a conference against the Criminal Law in Kamudi on May 12 and 13, 1934. Due to his continuous struggle, the law was repealed in 1948.

- He had visited Burma twice in the years 1936 and 1955.
- In 1938, he joined Comrade P. Jeevanandham in a struggle for the rights of workers working in a spinning mill in Madurai.
- During 1938, he was the leader of 23 workers unions in Madurai.
- He planned to hold a protest to enter the Madurai Vaidyanatha Iyer temple on the eighth Monday of July in 1939.
- He won the assembly elections held in 1946 unopposed. He contested the assembly and parliamentary elections held in 1952 and 1957 and won both.
- He won the 1962 parliamentary election despite being unable to campaign due to ill health.
- He respectfully called "Pasumpon Muthuramalingath".
- His memorial is located in Pasumpon. It is one of the important monuments of Tamil Nadu.

Sardar Vallabhbhai Patel

- He was born on 31 October 1875 in Nadi, Gujarat.
- A successful lawyer by profession, his career took a turning point when Mahatma Gandhi selected him as his deputy to lead the Kheda _ He also served as the Minister of Information Satyagraha in 1918.

- Patel led the Satyagraha movement in Nagpur in 1923 against the British law prohibiting the hoisting of the Indian flag.
- In 1924, he was elected as the Chairman of the Ahmedabad Municipal Board.
- On assuming office, he renovated the drainage, sanitation, cleanliness and water supply systems of Ahmedabad.
- It was his role in the Bardoli Satyagraha in 1928 that elevated him to a new peak of national glory. It was here that he earned the title of 'Sardar'.
- At the time of independence, India had 17 British Indian provinces, and the princely states, which constituted two-fifths of the country's geographical area, numbered over 560.
- Sardar Vallabhbhai Patel intervened to ensure the incorporation of the princely states into the Indian Union and to integrate them.
- He was appointed as the first Deputy Prime Minister and Home Minister of India from 1947 to 1950.

IUCN Conservation Award – "Fisher Friend" App

• The Fisher Friend mobile app received the

Tech4Nature Award at the IUCN World Conservation Congress held in Abu Dhabi.

The award recognizes the app's contribution to protecting the endangered Olive Ridley turtles and supporting coastal fishing communities.

Key Features of the Fisher Friend App:

- One major feature is the No-Fishing Zone Alert System.
- Using geolocation technology, the app sends an instant alert to fishermen if they enter a notified no-fishing zone. So far, the system has issued 7,000 alerts, helping prevent thousands of legal violations.
- Previously, legal boundaries were unknown **to many fishermen**, but the app now directly displays them, protecting turtles while keeping fishermen safe from penalties.
- The app was first developed after the 2004 Indian Ocean tsunami, supported Oualcomm and the Indian National Centre.
- It also provides alerts about marine hazards such as rocks, shipwrecks, and coral reefs.
- Fishermen in Tamil Nadu, Puducherry, and Andhra Pradesh now use the app to navigate safely and avoid marine risks.

Ga Sundarbans Aquaculture Model Wins FAO Global Award

- The Nature Environment and Wildlife Society (NEWS) of West Bengal's Sundarbans has earned global acclaim for its Sustainable Aquaculture in Mangrove **Ecosystems** (SAIME) model.
- The Food and Agriculture Organization (FAO) of the United Nations honoured NEWS with Global Technical Recognition on 15 October 2025.

- This award was given during FAO's 80th Anniversary Celebrations and the World Food Forum in Rome, Italy.
- SAIME is a pioneering approach that integrates aquaculture with mangrove conservation, climate adaptation, and sustainable livelihoods.

Vaikom Award

- A award given in recognition of contributions to social justice, equality and humanity.
- This award is given in memory of Vaikom hero Periyar E.V. Ramasamy for his social work.
- The year of inception of this award is 2022

- She is the founder of Equality Labs, a civil rights organization for the oppressed people of the United States and around the world
- Thenmozhi Soundararajan from the United States has been selected for the Vaikam Award for her work against caste discrimination in the United States and India and for her contributions to media and technological justice.

Booker Prize

- The Booker Prize Foundation has announced a new Booker Prize for children's fiction.

About Booker Prize

- The Booker Prize, considered the highest prize in English literature, has been awarded since 20 1969.

 - The book for this prize must have been published in the UK or Ireland in English or in English translation in the category of the best fiction for children aged 8 to 12.
 - This year's Booker Prize will be announced at an event in London on November 10.
 - The International Booker Prize for this year has been awarded to 'Hard Lamb', written by Kannada writer Banu Mushtaq and translated by Deepa Basti Given to the book.

Rashtriya Vigyan Puraskar (RVP) 2025 - National Awards for Scientific **Achievements**

- In addition to CO2, other greenhouse gases like methane (CH2) and nitrous oxide (N2O) also reached record levels in 2024.

- The new patrol vessel is named 'Akshar'.
- It is a state-of-the-art patrol ship built entirely within India.
- The vessel was constructed at the Goa Shipyard.
- It was built with 60% indigenous components.

KONKAN Exercise

- The Indian and British navies are set to conduct a joint naval exercise in the Indian Ocean for eight days.
- The exercise is being led by the British aircraft carrier HMS Prince of Wales.
- It is being conducted to demonstrate the commitment of both nations to ensuring safe and free sea routes.

DHUANI Hypersonic Missile

- It has been developed by the Defence Research and Development Organisation (DRDO).

- The INS Aandroth has been commissioned into the Indian Navy.

- The 41st Raising Day of the NSG was celebrated on 14 October 2025 at the headquarters of the Black Cat Commando unit in Manesar, Harvana.
- The Union Home Minister stated that a new center for the specially trained anti-terror and anti-hijack unit will be established in Ayodhya, Uttar Pradesh.
- Currently, NSG units operate in Mumbai, Chennai, Kolkata, Hyderabad, Ahmedabad, and Jammu.
- The Ayodhya center will be the seventh NSG center in India.

Exercise "Samudra Shakti"

- The Indian and Indonesian navies are jointly conducting a naval exercise named "Samudra Shakti" in Visakhapatnam.
- As part of the exercise, warships are departing the port under the guidance of tugboats.

India-UK Agreement

- The Indian Army has signed a contract worth Rs.4,100 crore with a UK company.
- Agreements were signed to strengthen bilateral ties across various sectors, including the defense sector.
- The Indian Army stated that this will fulfill the current and future requirements of the Ministry of Defense in achieving the Atmanirbhar Bharat (self-reliant India) goal.

India to supply Akash missiles to Brazil

- Akash is an indigenously manufactured air defense system in India.
- It has the capability to accurately strike and destroy aerial targets from the ground.

- India and Brazil have already decided to collaborate in the bilateral defense sector.
- The system can destroy enemy fighter aircraft, helicopters, and drones at a range of up to 25 km in the airspace.

Domestic Defence Production

- The central government aims to achieve 100% indigenisation in defence equipment production, according to the Defence Minister.
- In Nashik. Maharashtra, Hindustan Aeronautics Limited (HAL) has inaugurated a new division to manufacture Tejas MK-1A light combat aircraft, with plans to produce 24 aircraft.

BrahMos missile

- supersonic anti-ship missile jointly developed by India and Russia.
- Named after the first parts of the names of the Brahmaputra River and the Moskva River.
- Developed jointly by India's DRDO (Defence Russia's NPO Mashinostroyenia.
- Supersonic anti-ship and surface-to-surface missile. Up to Mach 2.8 (about three times the speed of sound).
- Initially 290 km, now expanded to 450 km.
- Used by the Indian Air Force and Army.
- · Can be launched from ships, submarines, aircraft and land.
- India is currently developing the BrahMos-2 Hypersonic (Mach 7 speed) missile.
- In 2024, the Philippines will be the first country to purchase BrahMos missiles from India.

Defence Production of the Country Has Increased Threefold

- The Prime Minister has said that the value of the country's defence sector production has increased threefold and crossed Rs. 1.5 lakh crore.
- INS Vikrant, the largest aircraft carrier built at the Kochi shipyard, was commissioned into the Navy in 2022. It is the first aircraft carrier built domestically.
- Ditya (another aircraft carrier). INS Surat, INS Marmagao, INS Chennai, INS Imphal, INS Kolkatta, INS Tushil, INS Thapar, INS Tej, INS Petwa, INS Deepak, INS Aditya, proved their mettle with the Brahmos and Akash missiles during Operation Sindhu.

Rafale fighter jet

- The Rafale aircraft, manufactured by France's Dassault Aviation, was formally inducted into the Indian Air Force in September 2020.
- Currently, 36 aircraft are in operation, and the Research and Development Organisation) and 201 Air Force has proposed to purchase 114 more aircraft.
 - Meanwhile, India and France finalized a deal in April to purchase 26 Rafale fighter jets for use on the Indian Navy's aircraft carrier INS Vikrant for Rs. 64,000 crore.
 - President Murmu flew a Sukhoi-30 fighter jet at the Air Force Station in Tezpur, Assam, on April 8, 2023.
 - It is noteworthy that former Presidents Abdul Kalam (2006) and Pratibha Patil (2009) have previously flown in the Sukhoi 30 fighter aircraft.

Trishul - Tri-Service Exercise

- Exercise Trishul is a large scale operational exercise scheduled by the Ministry of Defence to integrate multiple services in complex scenarios.
- A major tri-Service military drill, involving the Indian Army, Navy, and Air Force.
- The exercise runs from October 30 November 10.
- Location: Along the western border with Pakistan, spanning the states of Gujarat and Rajasthan.
 - To showcase joint operational capability and strategic preparedness, and enhance coordination and mission readiness among the three Services.

- Formed in 2006, replacing the former Human Rights Commission.
- Headquarters: Geneva, Switzerland.
- Objective: To monitor human rights violations, promote protection, and support the advancement of human rights globally.
- It serves as the principal international body for the protection of human rights.
- The Council has 47 member countries, each elected for a three-year term.
- Its functions include investigating human rights violations and providing recommendations and advice to countries.

International Maritime Organization (IMO)

- Member countries of the International Maritime Organization (IMO) postponed (delayed for a year) a vote on the strategic plan to move the shipping industry away from fossil fuel use and achieve "net-zero" by 2050.
- IMO 2023 GHG Strategy aims to:
 - Reduce carbon intensity of international shipping by at least 40% by 2030
 - Achieve net-zero emissions by 2050

About International Maritime Organisation (IMO)

 The International Maritime Organisation (IMO) is a specialized UN agency focused on

- regulating shipping and preventing marine pollution from ships.
- Established in 1948 and operational since 1958, the IMO has 175 member states and three associate members, with headquarters in London.
 - India joined in 1959.
 - The IMO creates a fair, effective regulatory framework for the shipping industry and addresses legal issues like liability and international maritime traffic facilitation.

ASEAN Summit

- India's participation highlights its role in regional and global groupings (Quad & BRICS).

Mahatma Gandhi's First Visit to Madras (1896)

- Mahatma Gandhi first visited Madras in October 1896 and addressed a gathering at Pachaiyappa's Hall.
- He spoke about the hardships faced by Indians in South Africa, many of whom were from Madras, highlighting how most were indentured labourers suffering severe illtreatment and denied legal protection.

G.D. Naidu - The 'Edison of India'

- G.D. Naidu, known as the 'Edison of India', was a pioneering inventor.
- During the Second World War, he manufactured mica capacitors and carbon resistors in Coimbatore.
- Along with 'Textool' Balasundaram, he built electric motors and invented vote recording machines, orange juice extractors, and coinoperated phonographs.

Elayaperumal Panel

- L. Elayaperumal, a three-time MP and onetime MLA of the Congress, led a committee on untouchability and Scheduled Castes development.
- The committee submitted its recommendations in 1969.

• The report helped abolish hereditary priesthood and allowed qualified individuals from all castes to serve as priests.

Central Electrochemical Research Institute (CECRI)

- The **Central Electrochemical Research Institute (CECRI)** was established at Karaikudi in 1948, a year after India's Independence.
- It was set up under the Council of Scientific and Industrial Research (CSIR).
- CECRI contributes to energy storage innovations and sustainable electrochemical technologies.

Ryotwari land revenue administration

- Thomas Munro, the Governor of Madras in the early 19th Century, and Captain Alexander Read introduced the Ryotwari system of land revenue administration in Madras in 1820.
- Later, it was extended to **Bombay**.
- It was an alternative to the **Zamindari** system
 with an aim to eliminate intermediaries in land

Brain-Eating Amoeba

- Primary Amoebic Meningoencephalitis (PAM) is a rare and often fatal brain infection caused by the amoeba Naegleria fowleri, commonly known as the "brain-eating amoeba."
- It is found in contaminated warm freshwater sources such as wells, ponds, and lakes.
- Transmission: Naegleria fowleri enters the body through the nose when a person swims or bathes in contaminated freshwater. It then travels to the brain, causing tissue destruction and inflammation.
- It does not spread through drinking water or from person to person.

Ban on Using the Word "ORS" on Food **Products**

- The Food Safety and Standards Authority The Tamil Nadu Small Industries Corporation of India (FSSAI) has directed all food manufacturing companies to stop using the term "ORS" on labels and advertisements.
- Using "ORS" as part of a brand name or on packaging violates the Food Safety and Standards Act, 2006.
- The permissions granted in July 2022 and February 2024 allowing the use of the term "ORS" have now been withdrawn, according to FSSAI.

Food Safety and Standards Authority of India (FSSAI)

- The FSSAI is an autonomous statutory body established under the Food Safety and Standards Act, 2006.
- It functions under the Ministry of Health and Family Welfare, Government of India.
- Headquarters: New Delhi.
- Its objectives include setting food standards, 20 ensuring safe food practices, licensing food businesses, ensuring compliance through inspections, testing food quality, training 0 and capacity building, and promoting public awareness.

Decisive war between East India **Company and Mysore forces**

- Porto Novo, meaning New Port in Portuguese, is located on the north bank of the mouth of the Vellar River in Cuddalore district.
- This place is now known as Parangipettai. The British East India Company defeated Hyder Ali's troops in the Battle of Porto Novo which took place in July 1781.

The Tamil Nadu Small Industries **Corporation Limited (TANSI)**

- Limited (TANSI) was set up on December 1, 1965 to take over small industrial units run by the Department of Industries and Commerce.
- These units were set up during the first three Five-Year Plans to promote industrial growth.
- TANSI later entered other small-scale sectors.

Arumbavur wood carvings

- The Arumbayur wood carvings Perambalur district are renowned for intricate craftsmanship and traditional designs.
- They are made entirely by hand. Artisans use woods like Aththi, Maavilangai, Vaagai, Vembu, Vengai, and teak, while temple cars are carved from Illuppai.
- The craft received the GI tag in 2020.

Ordnance Factory

- Ordnance Factory Tiruchirappalli established on July 3, 1966 by Prime Minister Indira Gandhi, is India's largest small arms manufacturer.
- It began production in 1967 and was earlier part of the Ordnance Factory Board.
- OFT produces a wide range of rifles, carbines, and light machine guns for defence forces.

Madras Observatory

- Madras Observatory, one of the earliest astronomical and meteorological observatories in India, was opened by Governor Sir Charles Oakeley in 1792.
- It marked the start of systematic weather observation in the region, decades before India Meteorological Department was set up in 1875.

CURRENT FACTS

- National Pension Scheme -Made mandatory for central government employees from January 1, 2004.
- PFRDA (Pension Fund Regulatory and Development Authority) was established on August 23, 2003.
- Bihar's first Metro rail service started in Patna.
- Meaning of Chennai Kattibara Flyover -Kattibara means "Sword Parade". The name comes from the fact that in this area, which was once a military cantonment, parades were conducted with soldiers carrying swords upright, hence the name Kattibara.
- Argentina is the second-largest country in South America and the 8th largest in the world. It features the highest point in the Southern Hemisphere, Mount Aconcagua, and the lowest point, Laguna del Carbon Lake
- The Tamil Nadu Pollution Control Board (TNPCB) Established in 1982, is the state body responsible for preventing and controlling water, air, and land pollution by enforcing the Water Act, Air Act, and the Environment (Protection) Act.
- National Green Tribunal (NGT) It is a specialized statutory body established in 2010 under the National Green Tribunal Act to handle environmental disputes and ensures quick justice on matters of environment protection and resource conservation.
- St. Thomas Mount Church built on top of the hill bearing the names Punitha Thomaiyar Malai and Parangi Malai was built by the Portuguese in 1523.
- In India, the Model Code of Conduct (MCC) guidelines are issued by the Election Commission of India (ECI).
- The Central Government has declared Tamil Nadu's Meghamalai as India's 51st Tiger Reserve.
 This forest area spread across Theni and Madurai districts is the Tamil Nadu continuation of Kerala's Periyar Tiger Reserve.
- Fort St. George, where the Tamil Nadu government's headquarters is located, was completed on April 23, 1644. It is under the control of the Tamil Nadu Archaeological Department. The museum here also has the national flag that was first hoisted in our country.
- National Security Advisor (NSA) of India Ajit Doval.
- During World War I, on September 22, 1914, Germany's Emden warship attacked Chennai. The bomb that exploded then hit the High Court compound wall. A plaque regarding this is still on the High Court wall till today.
- Article 370 of the Indian Constitution Granted special status to the state of Jammu and Kashmir, allowing it to have its own constitution and significant autonomy over its internal affairs, with only defence, foreign affairs, and communications remaining under the central government's direct control. In August 2019, the Indian government revoked Article 370 through a Presidential Order, which was upheld by the Supreme Court in December 2023.
- Armenia is the first country in the world to officially adopt Christianity. About 97% of its population follows Christianity. Its capital, Yerevan, is one of the oldest cities in the world.
- In the 1st century AD, Roman merchants traveled to the seas of other countries through Chengal for trade. In a travelogue written by these Roman merchants, there is a mention of "Pazhaveerkadu port city."

- The Semparambakkam Lake, spread over an area of 15.38 sq. km in Thiruvallur and Kanchipuram, is 24 feet deep with a capacity of 3,645 million cubic feet. This lake is the first artificial lake built by King Rajendra Chola I.
- Jnanpith Award: It was first awarded in 1965 to Sankar Guru from Kerala, and the 59th award (2024) was given to Vinod Kumar Shukla from Chhattisgarh.
- One of South India's oldest Catholic churches is Mylapore's Luz Church. It was built in 1516 by the Portuguese in the old European architectural style. Last August, its 509th annual feast was celebrated.
- The world's first democratic election was the Uthiramerur Kudavolai system election of the 10th century. Even then, those who had misappropriated others' property or had relationships with other women were not allowed to contest.
- The Nobel Prize is the most prestigious award given for literature. Other notable literary awards include the Man Booker Prize, International Booker Prize, Pulitzer Prize, and Hugo Award.
- The ancient St. Mary's Church, located within the Fort St. George complex, was consecrated on October 28, 1680. It is the oldest British building in India, built with contributions from the English residents who lived in the fort during that period.
- During British rule, in 1670, Sir William Langton, who served as the Governor of Madras, first formed a mounted cavalry unit with 7 horses. This cavalry later evolved into a separate division of the Chennai Police Department.
- In Tamil Nadu's Budget estimates for 2025-26, the Debt to GSDP Ratio was projected to be 26.07%, well within the target of 28.70% prescribed under the 15th Finance Commission.
- Operation Blue Star: It was a military operation carried out from June 1 to June 10, 1984, with the objective of flushing out and arresting the terrorists who were hiding inside the Golden Temple in Amritsar, Punjab.
- India's first zoo was established in 1855 at Moore Market, Chennai. Later, the zoo was moved to Vandalur to allow the animals to live in their natural environment. It was inaugurated by the then Chief Minister MGR on July 24, 1985.
- The Kalinga Prize was established by UNESCO in 1952 through a donation from Biju Patnaik, founder of the Kalinga Foundation. This international award is given to individuals who communicate scientific ideas and discoveries.
- Thomas Munro was a Major General in the British Army and Governor of Madras from 1820 to 1827
- The Supreme Court of India was established on 28 January 1950. The first Chief Justice of the Supreme Court was Harilal Jagisundas Kaniya. He held the office till 6 November 1951
- In India, 89,507 cases are pending in the Supreme Court, 63,62,168 cases in the state high courts, and 4,70,81,356 cases in the district and lower courts across the country.
- According to the Budget Estimates for Tamil Nadu for 2025-26, the debt-to-GDP ratio is projected to be 26.07%, which is within the target of 28.70% set under the 15th Finance Commission.
- India's first woman doctor, Muthulakshmi Reddy, started a 12-bed cancer hospital in Adyar in 1954 with a fund of Rs. 1 lakh raised through the Indian Women's Association after her younger sister died of cancer.

- Tamil is one of the four official languages of Singapore. Along with English, Malay, and Chinese,
 Tamil is used as an official language in Parliament.
- The Internet is also home to a student meal plan, created by StudentRecipes.com.It contains over 4,000 food types and cooking methods.
- Madame Blavatsky and Colonel Olcott founded the Theosophical Society in New York in 1875.
 After 1879, its headquarters were located in Adyar, Chennai. Annie Besant popularized the movement in India.
- The 2025 International Booker Prize has been awarded to Kannada writer Banu Mushtaq's novel 'Heart Lamp'. It is the first International Booker Prize to be won by a Kannada-language writer.
- Vanji and Nocchi are two categories of words found in the Purathinai. Vanji refers to the act of war to conquer the enemy's country and the burning of the Vanji flower. Nocchi refers to standing guard over the enemy's fort.
- The Victoria Public Theatre was built in 1888 to commemorate the Golden Jubilee of Queen Victoria's reign under British rule. It was here that films were screened for the first time in Tamil Nadu in 1889.
- Savitribai Phule India's first female teacher, she worked resolutely in the 19th century to provide education to women, overcoming social oppression and humiliation.
- Sangeet Natak Akademi Award This award is presented by India's National Academy for Music,
 Dance, and Drama. It is considered the highest national recognition in the field of arts.
- University of Madras Established in 1857, this is one of the country's oldest universities. It has produced renowned scientists, politicians, and artists, and holds the distinction of creating the first Tamil dictionary among Indian languages.
- Royapuram Railway Station India's second oldest railway station, where South India's first train ran in June 1856. It remains one of the oldest operational railway stations in the country.
- Kanchipuram Kumarakottam Temple (Senadheeswaram) Revered as a sacred place of knowledge, clarity, and peace, it is associated with the Kanda Puranam. The Kalmandapam where Kanda Puranam was recited is now Kachiyappar Library.
- 2023 International Year of Millets Declared by the United Nations, highlighting India's leadership as the world's largest producer of millets.
- India World's Largest Milk Producer Within India, Uttar Pradesh ranks first, Rajasthan second, and Madhya Pradesh third in milk production.
- Chennai Central Railway Station was established in 1873, designed by George Harding and later modified by Robert Fellowes Chisholm.
- Egmore Railway Station was opened in 1908.
- Palaverkadu Lake in Thiruvallur district is the second-largest brackish water lake in India. Rivers such as Swarnamukhi, Kalangi, and Arani from Andhra Pradesh flow into Palaverkadu Lake
- Pugazhendi Pulavar, a poet from the Pandya-Chola period, wrote Nala Venpavai. Varaguna Pandiyan Avai served as a poet. He was born in Ponvilainthakalthur near Chengalpattu, where a mandapam (memorial hall) has been established in his honor.
- M. Bhaktavatsalam, former Chief Minister of Madras State, was born in Nasarathpettai near Poondhamalli. A freedom fighter, he served as Chief Minister from 1963 to 1967. His daughter is Sarojini Varadappan, a Padma Shri awardee.

- Adyar River originates in Kanchipuram district, flows through Chengalpattu and Chennai districts for 42 km, and empties into the Bay of Bengal. Its tributaries pass through around 31 lakes in Thiruvallur, Kanchipuram, Chengalpattu, and Chennai districts.
- The Conference of Parties (COP) pre-meetings will be held on 10 November in Palem, Brazil.
- The Kodaikanal Star Lake was constructed in 1863 by Henry Levinge. Initially, the lake served as a drinking water source.
- In Virudhunagar District, there are 450 village panchayats and 608 revenue villages, along with 7 Assembly constituencies
- Uranus, the seventh planet from the Sun, is classified as an ice giant. It has 13 rings and is composed mainly of water, ammonia, and methane ice.

- The Frankfurt Book Fair in Germany is considered the world's largest book fair. This year, it began on October 11 and will conclude on October 19 (tomorrow).
- Chennai Airport, India's fifth busiest airport, saw its first flight service begin in 1916, and it has been in regular operation since 1930
- Hans Kammerlander, an Italian mountaineer, set a record in 1996 by climbing Mount Everest without using supplemental oxygen. He reached the summit in 16 hours and 45 minutes.
- India's first meteorological observatory was established in 1792 at Nungambakkam, Chennai. It has been recording and documenting weather data daily for over 140 years without interruption, earning recognition as a World Meteorological Centre.
- When linguistic reorganization of Indian states took place in 1956, Tiruttani, a Tamil-majority area, was merged with Andhra Pradesh. Due to the efforts and protests led by Ma. Po. Si, Thalapathi Vinayagam, and Mangalangizh, Tiruttani was rejoined with Tamil Nadu on April 1, 1960.
- Kalaignar Magalir Urimai Thittam- It was launched on September 15, 2023, the birth anniversary of former Chief Minister Annadurai. Women, who have completed 21 years of age (born before September 15, 2002), are eligible to apply for the scheme
- Crew Escape System (CES): The Crew Escape System is a rapid-acting safety mechanism developed to eject the crew module carrying astronauts away from a malfunctioning launch vehicle during an emergency. - The Tamil Nadu Factories Rules, 1950, framed under the Factories Act, 1948 to ensure the occupational safety, health, and welfare of workers in factories located in Tamil Nadu.
- India and China are the two biggest buyers of Russian oil.
- Reliance Industries Ltd (RIL) Operates the world's largest refinery complex at Jamnagar, Gujarat.
 India's top buyer of Russian crude.
- The Adyar River Starts near Chembarambakkam Lake in Kanchipuram district, Tamil Nadu. It is one of three rivers flowing through Chennai and joins the Bay of Bengal at the Adyar Estuary. The remaining two are the Cooum and the Kosasthalaiyar.
- Cutting-edge semiconductor research: Applied Materials India Chairman Avi Aula said the collaboration with IIT Madras will accelerate the development of a strong semiconductor ecosystem in India.
- Pallikaranai Marshland A freshwater and partly saline wetland located in Chennai, Tamil Nadu, was designated a Ramsar Site in 2022.

- The Government Eye Hospital, Egmore, Chennai was founded in 1819 by Dr. Robert Richardson. Asia's first eye bank was established here, where the continent's first eye transplant was also performed.
- The Madras High Court is one of the three High Courts established in 1862 by the Charter of Queen Victoria. It is the second largest court complex in the world.
- Professor Zhang Baosheng Translated the Bhagavad Gita into Chinese.
- The Chief Justice of the Madras High Court Justice Manindra Mohan Shrivastava.
- Chief Election Commissioner (CEC) of India: Gyanesh Kumar
- According to UNESCO, a total of 7,000 languages are currently spoken in many parts of the world. According to UNESCO, 40% of these, i.e. 2,800 languages, are on the verge of extinction soon.

- The Chennai Port, which is the second largest port in India, was opened in 1881. It is a major factor in the economic growth of Tamil Nadu. In 2024-25, this port handled a record 54.96 million metric tons of cargo.
- The Naxalite problem arose in Tamil Nadu during the years 1967-1970. In order to monitor and arrest them, Q Division was formed in the Tamil Nadu Police Department in 1976. Its name was changed to Q Division Criminal Investigation Department.
- The Sepoy Mutiny took place in Vellore Fort on July 10, 1806. About 115 people, including 15 British officers and 83 soldiers, were killed in this. This is considered the seed of the first Indian freedom struggle.
- Russia's SJ-100 passenger plane is to be manufactured in India by HAL.
- The first trial of artificial rain to reduce the increasing air pollution problem in Delhi was held on 28.10.2025 after 53 years.
- At the Pushkar Livestock Fair in Rajasthan, one of the most famous livestock fairs in India, a horse worth Rs. 15 crore, a buffalo worth Rs. 23 crore and a cow measuring just 16 inches tall were sold and attracted the attention of visitors.
- The foundation stone of the Chennai District Central Library was laid in 1960 and was opened on Nov. 10, 1965 by the Governor of Madras, Maharaja Jaya Chamaraja Wodeyar, in the presence of Chief Minister M. Bhaktavaswama. It was named Devaniya Bhavanar District Central Library in 1981
- A study published in the Lancet magazine has found that 5.13 percent of farmers in Tamil Nadu have impaired kidney function. A team led by Dr. N. Gopalakrishnan, Secretary of the State Organ Transplant Commission, conducted the study.
- The Kudiyam Caves are located in the Allikuzhi mountain range near Uthukottai. Robert Bruce Boot, known by historians as the father of Indian archeology, recorded in 1864 that these were caves inhabited by ancient people.
- Kanchipuram was once called 'Kadigasthanam' or 'Place of Learning'. It was a major centre of learning for Buddhism, Jainism, and Hinduism. The famous Buddhist scholar Dharmapala was born here.
- The Indian Metro Rail service is currently operating in 23 cities, covering a total distance of 1,032 kilometers. India is the country with the third largest metro rail service in the world, after China and the United States.
- Chairperson of the Tamil Nadu State Commission for the Scheduled Castes and the Scheduled Tribes - Justice S. Tamilvanan.

- Vivekananda House is the place where Swami Vivekananda stayed for 9 days from 6th to 15th February 1897 after returning from a lecture in Chicago, USA. It is reported that he delivered 9 famous lectures here.
- Vivekananda House was a ' "Ice House' used by the British to store ice cubes in 1842. Later, it became a naval accommodation called 'Marine Mansion'. It is known by its current name because of Vivekananda's stay.
- Birds coming from Vedanthangal search for food at the Karikili Bird Sanctuary, 3 km away. It was declared a bird sanctuary in 1988 by merging the 2 lakes. It was declared a Ramsar site in 2022.
- The Alamparai Fort was built by the Mughal Empire in the late 17th century near Chengai, Kadapakkam. When it was a port in ancient times, clothes, salt, and ghee were exported. Now, it is a dilapidated historical monument. Vetrii IAS Study Circ
